Quarter 1

Covering the cost of providing additional technology hardware to students, such as laptops or tablets, or covering the added cost of technology fees:

The CARES 18004(a)(1) Institutional Funds were used to purchase 875 Chromebooks that can be "checked out" of the library so students can continue participate in remote learning. In addition to the Chromebooks, protective sleeves were also purchased to enhance durability while loaned out to the students.

Providing or subsidizing the costs of high-speed internet to students or faculty to transition to an online environment:

CARES 18004(a)(1) Institutional Funds were used to support the costs of expanded capacity of WebEx for remote advising, meeting with faculty, etc. The funds were also used to purchase MobileCitizen Hotspots that students can borrow to ensure reliable internet connection for the remote learning environment. Funds were used for the license fee of GoReact, which is a cloud-based teaching platform.

Campus safety and operations:

Funding was used from the CARES 18004(a)(1) Institutional Funds to ensure the safety of the campus for a hybrid learning environment. The College purchased many supplies of PPE, including disposable gloves, masks, alcohol wipes, face shields, and hand sanitizer that can be used by faculty, staff, and students. Tyvex Coveralls were provided to cleaning staff. Electrostatic hand sanitizer stations were purchased and placed among the campus. Paper towel dispensers were placed in bathrooms of re-opened buildings based on the Covid-19 guidelines.

To maintain social distancing, acrylic panels and "sneeze guards" were purchased. The College also purchased floor directional signs for hallways, stairways, and laboratories. Additional signs were placed to mark areas for authorized personnel only or no entry/exit (for creating one-way stairways or hallways). Signs were also used to direct people to temperature check points. The CARES 18004(a)(1) Institutional Funds were also used to support the payment of personnel hired to operate the temperature check points, ensuring no personnel on campus had temperatures and everyone was wearing a mask. When a positive COVID-19 test is revealed, the buildings the individual entered undergo a decontamination cleaning. The funds were used to offset those costs. Water quality testing was performed prior to re-opening the campus to online learning. The testing was necessary due to lack of use from campus closure.

Purchasing, leasing, or renting additional equipment or software to enable distance learning, or upgrading campus wi-fi access or extending open networks to parking lots or public spaces, etc:

To adapt to the remote learning and working environment, the College had to upgrade the firewall security for remote connection as well as increasing the server volume load. Laptops were purchased to be loaned to faculty or staff that didn't have reliable access to one at home. Prior to COVID-19, a family of four may have been able to share a single computer but with the current environment, every family member would need consistent, reliable computer access for working and/or teaching. In addition to the laptops, the College purchased wireless Cisco phones to faculty and staff could continue remote student support, such as advising and financial aid information. Additional office supplies were purchased to be lent to faculty and staff to allow for remote learning and work, such as portable hard drives, wireless headsets, and screen recorders.

In order to provide remote advising to students, Citrix licenses were purchased for academic advisors at the College. Funds were also utilized to support RescueAssist IT support for faculty and students to allow a seamless learning environment.

Other Uses of (a)(1) Institutional Portion funds:

Due to the remote work environment, faculty and staff of the College are needed to increase their internet speeds as well as other utility costs from being home. A stipend has been provided to College personnel to accommodate these extra costs. When campus returns to normal operations, the stipend will no longer be provided. The stipend is being offset with CARES 18004(a)(1) Institutional Funds.
