Providing additional emergency financial aid grants to students

CRRSAA 314(a)(1) Institutional Funds were used to provide additional emergency financial aid grants to students. Students that completed a CRRSAA Student Emergency Aid application and were enrolled at Harper College at the time of application review, received an award that was a minimum of \$260 or a maximum of \$2,010 for exceptionally needy cases. The funds for these awards derive from CRRSAA 314(a)(1) Institutional Funds as of May 26, 2021 as the Student Funds were exhausted.

Covering the cost of providing additional technology hardware to students, such as laptops or tablets, or covering the added cost of technology fees.

The purchase of four computer desk kiosks, the monitors, printers, computer stands, and privacy screens were purchased using CRRSAA 314(a)(1) Institutional Funds. These computer kiosks and computer stands were purchased to ensure social distancing while in use.

Providing or subsidizing the costs of high-speed internet to students or faculty to transition to an online environment:

CRRSAA 314(a)(1) Institutional Funds were used to pay for the Verizon Hotspots usage that students can borrow to ensure reliable internet connection for the remote learning environment. Funds were also used for a Creative Cloud educational subscription for classroom use. CRRSAA 314(a)(1) Institutional Funds were used to purchase the GoReact video assessment software to review student skill development.

Campus safety and operations:

Funding was used from the CRRSAA 314(a)(1) Institutional Funds to ensure the safety of the campus for a hybrid learning environment. Deep cleaning was performed after confirmed cases of students with COVID-19 attending campus. In addition, PPE, directional signage, plexi-glass, transparent screens, and water testing were purchased. During this quarter, Harper College hired checkpoint screeners who took temperatures and ensured mask usage compliance. Their wages were offset using CRRSAA 314(a)(1) Institutional Funds.

Purchasing, leasing, or renting additional instructional equipment and supplies (such as laboratory equipment or computers) to reduce the number of students sharing equipment or supplies during a single class period and to provide time for disinfection between uses:

CRRSAA 314(a)(1) Institutional Funds were used to purchase Honorlock testing units to allow for remote exam proctoring.

Purchasing, leasing, or renting additional equipment or software to enable distance learning, or upgrading campus wi-fi access or extending open networks to parking lots or public spaces, etc:

With the staggered return to on-campus operations, the College has purchased headsets and webcams for staff and faculty use. These purchases allow staff and faculty on or off campus to continue to participate in WebEx or Zoom meetings. In addition, due to the continued remote learning and work, a necessary firewall upgrade was purchased. The cost of these items was directed to CRRSAA 314(a)(1) Institutional Funds.

Other Uses of (a)(1) Institutional Portion funds:

The College has provided a stipend to faculty and staff each pay period to accommodate their need for increased internet speed as well as other utility costs incurred as a result of working from home. When campus returns to normal operations, the stipend will no longer be provided. The stipend is being offset with CRRSAA 314(a)(1) Institutional Funds.
