**Quarter 3**

Providing or subsidizing the costs of high-speed internet to students or faculty to transition to an online environment:

CARES 18004(a)(1) Institutional Funds were used to purchase additional Verizon Hotspots that students can borrow to ensure reliable internet connection for the remote learning environment.

Campus safety and operations:

Funding was used from the CARES 18004(a)(1) Institutional Funds to ensure the safety of the essential personnel maintaining the safety of the campus. As the campus was closed to students for most of the third quarter, supplies of PPE were reduced. Masks were purchased for the Harper College Police Department as they continued to support the campus. In addition, two water tests were purchased to ensure quality while the campus was closed and plumbing under-utilized.

Purchasing, leasing, or renting additional instructional equipment and supplies (such as laboratory equipment or computers) to reduce the number of students sharing equipment or supplies during a single class period and to provide time for disinfection between uses:

The CARES 18004(a)(1) Institutional Funds were used to support the use of Honorlock, a remote exam proctoring service utilized by Harper College as a result of the online learning environment.

Purchasing, leasing, or renting additional equipment or software to enable distance learning, or upgrading campus wi-fi access or extending open networks to parking lots or public spaces, etc:

With the continued remote learning and working environment, the College has paid for additional Webex functions through Webex Assistant. The cost of this upgrade was covered by CARES 18004(a)(1) Institutional Funds.

Other Uses of (a)(1) Institutional Portion funds:

The College has provided a stipend to faculty and staff each pay period to accommodate their need for increased internet speed as well as other utility costs incurred as a result of working from home. When campus returns to normal operations, the stipend will no longer be provided. The stipend is being offset with CARES 18004(a)(1) Institutional Funds.
