6. Qualification: Pre-Qualifying AIA Form A305 must be submitted to the Owner with the Bid.

All Bidders must comply with the following: Contractor shall pay not less than the prevailing rates of wages to all laborers, workmen and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
8. Bid security in the form of an AIA bid bond or certified check in an amount equal to ten percent (10%) of the aggregate of the Base Bid and all Alternate Bids.
