Bids will be received in the Purchasing Department, Building A, Room A217 and will be opened publically directly following the deadline for receipt of bids.
1. The project includes (but is not limited to) the following: mobilization, site preparation, erosion and sediment control, demolition, concrete paving, joint sealing, earthwork/grading, site furnishings, storm sewer, and underdrainage.

- D. Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
