- A. Sealed bids in triplicate for the construction of Harper College – Building M and U Communications Cabling will be received by purchasing at Harper College at Room A217, Building A, 1200 West Algonquin Road, on the Harper College Campus in Palatine, IL 60067 until 11:00 A.M. local time, on December 8, 2017 and will be read aloud shortly thereafter.
 - 1. The project includes the extension of telecommunications fiber and copper cabling between building U and M to building Y and A. Cabling will be routed in previously installed raceway.
 - 2. A non-mandatory, pre-bid submission meeting and site visit will be held on November 29, 2017 at 2:00 p.m. at Harper College, Building A, Room A-315 B.C – Palatine Campus, 1200 West Algonquin Road, Palatine, IL 60067. Interested parties are strongly encouraged to attend as this will be the only opportunity for an escorted site visit.

- C. Bidder must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.
