

## ADVERTISEMENT FOR BIDS

- A. SEALED BIDS WILL BE RECEIVED BY THE BOARD OF TRUSTEES, HARPER COLLEGE, ON THURSDAY, SEPTEMBER 20, 2018 AT 11:00 A.M. PREVAILING TIME FOR FURNISHING ALL NECESSARY LABOR, EQUIPMENT, AND MATERIAL FOR THE 2018 BUILDING R FLYTOWER ROOF REMOVAL AND REPLACEMENT - BID REQUEST NO. Q00936 AT HARPER COLLEGE AT 1200 W. ALGONQUIN ROAD, PALATINE, ILLINOIS 60067.
- B. The Work consists of removal and replacement of the existing roofing system over a portion of the Building R performing arts center. Work includes (but is not limited to) the following: removal of existing prefinished metal copings, fully adhered black EPDM membrane, flashings, and mechanically fastened / adhered rigid insulation; installation of new vapor barrier on a concrete deck, roof anchorage posts, portable roof fall protection equipment, fully adhered flat and tapered rigid insulation, white EPDM membrane system, flashings, and mill finish copings.
- C. Lump sum bid proposals will be received for this project at the scheduled time of receipt of bids and will be publicly opened and read aloud.
- D. A non-mandatory Pre-Bid meeting has been scheduled for 2:00 p.m. on Friday, September 7, 2018, prevailing time at 1200 W. Algonquin Road, Palatine, Illinois, Building W- Room W-218. All Bidders are encouraged to attend and sign in at the meeting which will also be attended by the Owner and Architect.
- E. Bid security in the form of bid bond in an amount equal to 10 percent (10%) of the aggregate of the Base Bid amount and all Alternate Bid amounts shall be submitted with the bid.
- F. Performance, Labor and Material Payment Bonds, and Certificate of Insurance will be required from the successful bidder
- G. Bids shall be submitted in an opaque sealed envelope addressed to: Harper College, Purchasing Department, located in A-Building, Room A217, 1200 W. Algonquin Road, Palatine, Illinois 60067.
- H. No bid may be withdrawn for a period of ninety days after the submission without the consent of the Board of Trustees.
- I. Any bid submitted unsealed, unsigned, fax transmission, e-mail, or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder.
- J. Harper College reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in bidding procedures, and to award the contract in a manner best serving the interest of the College.
- K. All bidders must comply with applicable Illinois Law requiring the payment of prevailing wages by all Contractors working on public works. Bidder must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.
- L. Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract, and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
- M. Bidders shall comply with the Business Enterprise Program: Participation and Utilization Plan developed by Harper College. There is a 20 percent aspirational goal on the Contract.
