1.1 BID INFORMATION

- A. Sealed bids are to be delivered to the Harper College Purchasing Department on or before Tuesday, April 2, 2024, at 11:00 a.m. Central Time for Building M Utility Piping Relocation & Building U Heating Hot Water Plant Replacement project Request for Bid No. Q01141 in Building A, Room A-217 on the Harper College campus located at 1200 West Algonquin Road, Palatine, IL 60067.
- B. Mechanical, electrical, plumbing, architectural, structural, temperature controls, and civil scope of work for the new pipe routing from Building B to Building M, and the new heating hot water plant in Building U includes but is not limited to:
 - 1. Route new high-pressure steam and pumped condensate piping from the existing underground steam vault at Building B, through Buildings U and S, to the Building M mechanical room.
 - 2. Provide pipe anchors, guides, expansion joints, and structural support. Reinforce existing structural framing where required.
 - 3. Provide a new mechanical room in Building U complete with electrical power, lights, ventilation, heating, and controls.
 - 4. Provide new steam-to-hot-water heating plant in Building U complete with steam PRV station, heat exchangers, condensate return unit, hot water pumps, variable frequency drives, temperature controls, etc.
 - 5. Provide emergency power from Building B to the new heating plant in Building U.
 - 6. Connect new heating hot water plant to existing Building S hot water heating system. Provide stub-out pipe connections for future connection to Building U and T.
 - 7. Demolish existing hot water boiler plant in Building S.
- C. Lump sum bid proposals will be received for this project at the scheduled time of receipt of bids and will be publicly opened and read aloud shortly thereafter.
- D. A non-mandatory pre-bid meeting has been scheduled for 2:00 p.m. Central Time on Tuesday, March 12, 2024, at Harper College, 1200 W. Algonquin Road, Palatine, Illinois 60067 in Building W, Room W-218. All bidders are encouraged to attend and sign-in at the meeting, which will also be attended by the Owner and Engineer and will be the only opportunity for an escorted walk through of the site.
- E. Bid security in the form of bid bond in an amount equal to 10 percent (10%) of the aggregate of the Base Bid amount and all Alternate Bid amounts shall be submitted with the bid.
- F. Performance, Labor and Material Payment Bonds, and Certificate of Insurance will be required from the successful bidder.
- G. Bids shall be submitted in an opaque sealed envelope addressed to: Harper College, Purchasing Department, located in A-Building, Room A-217, 1200 W. Algonquin Road; Palatine, Illinois 60067.
- H. No bid may be withdrawn for a period of ninety days after submission without the consent of the Board of Trustees.

- I. Any bid submitted unsealed, unsigned, fax transmission, e-mail, or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder.
- J. Harper College reserves the right to reject any or all bids or parts thereof, to waive any irregularities or informalities in bidding procedures, and to award the contract in a manner best serving the interest of the College.
- K. All bidders must comply with applicable Illinois Law requiring the payment of prevailing wages by all Contractors working on public works. Bidder must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.
- L. Contractors shall pay not less than the prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract and shall comply with the requirements of the Illinois Wages of Employees on Public Works Act (820 ILCS 130/1-12).
- M. Bidders shall comply with Business Enterprise Program: Participation and Utilization Plan developed by Harper College. There is a 30 percent aspirational goal on the contract.
