Students who are interested in enrolling in a Study Abroad Program may be eligible to use financial aid to assist in paying for Study Abroad costs. In order to utilize financial aid, students must complete a Free Application for Federal Student Aid (FAFSA) and have financial aid eligibility for the semester in which they plan to enroll. Students should be prepared to cover expenses that cannot be covered by financial aid due to a lack of funds or disbursement date.
