BY INVESTING DIRECTLY IN STUDENTS PARTICULARLY THOSE FACING ECONOMIC, PERSONAL, OR SYSTEMIC CHALLENGES THE FOUNDATION ADVANCES EDUCATIONAL ACCESS, STUDENT SUCCESS, AND LONG-TERM ECONOMIC MOBILITY.

PROGRAM GRANTS: THROUGH THE RESOURCES FOR EXCELLENCE GRANT (RFE) PROGRAM, THE FOUNDATION PROVIDES SEED FUNDING FOR INNOVATIVE TEACHING, FACULTY DEVELOPMENT, AND NEW ACADEMIC PROGRAMMING THAT MEETS THE RAPIDLY CHANGING NEEDS OF STUDENTS AND THE WORKFORCE.
