RESOLUTION

WHENEAS the regular annual election in and for the Board of Trustees of Junior College District No. 512, Counties of Cook, Kane, Lake, and McHenry, State of Illinois, was held on the 10th day of April, 1971, for the purpose of electing three members of the Board of said District to serve for the full three year term, and

WHEREAS this Board has caused proper notice of said election to be given to the electors of said district by publishing a notice thereof once in a newspaper published in said district, the date of said publication being more than ten days prior to said election, and

WHEREAS proper ballots were used at said election, and

WHEREAS the returns of said election have been submitted to this Board for canvassing thereof as provided by law,

NOW, THEREFORE, BE IT AND IT IS HERRBY RESOLVED by the Board of Trustees of Junior College District No. 512, Counties of Cook, Kane, Lake, and McHenry, State of Illinois, as follows:

Section 1. That this Board has given proper notice of and that proper ballots were used at the regular annual election for members of the Board of Trustees of Junior College District No. 512, Counties of Cook, Kane, Lake, and McHenry, State of Illinois, held in and for said district on Saturday, the 10th day of April, 1971.

Section 2. That the total number of votes cast at said election for members of the Board to serve for the

three year terms as shown on the voters' affidavits, which were used in lieu of poll books pursuant to a duly adopted resolution of this Board was 13.519.

Section 3. That the following candidates for members of the Board to serve for the three year terms received the number of votes set opposite their respective names:

H. Wilson - 5991 votes

L. Moran - 3076 votes

M. Hansen - 6760 votes

R. Miller - 6602 votes

G. Beery - 1677 votes R. Fuchs - 2949 votes

E. Nugent - 6497 votes

L. Barry - 2640 votes

Section 4. That it is hereby found and determined that Mr. Hansen , Mr. Miller and Mr. Nugent , received a plurality of the votes cast and by the proceedings aforesaid have each been elected a member of the Board of Trustees of Junior College District No. 512, Counties of Cook, Kane, Lake, and McHenry, State of Illinois.

Comments of Canvassing Committee at April 19, 1971 Board meeting:

At the completion of the canvass, Member Haas announced the certification sheets corresponded with the unofficial returns as submitted. Member Haas stated however that in Precinct #4, the tally sheet showed 292 votes for R. Miller and the certificate of results showed 297 votes; in Precinct #12 the tally sheet showed 41 votes for R. Fuchs, and the certificate of results showed 46 votes; in Precinct #20 the judges showed two lines, one for R. Miller and one for L. Miller, but both tally and certificate showed 334 votes for Miller; in Precinct #30 the judges had used a different type of tally sheet but the tally and certified results agreed; in Precinct #34, the tally sheet showed 21 votes for G. Beery and the certified results showed 26 votes.
