Minutes of the Special Board Meeting of Thursday, May 23, 1974

CALL TO ORDER:

The special meeting of the Board of Trustees of Community College District No. 512 on Thursday, May 23, 1974, was called to order by Chairman Kelly at 8:48 p.m., in the Board Room of the Administration Building, Algonquin and Roselle Roads, Palatine.

NEW BUSINESS: Non-academic Salaries and Monetary Fringe Benefits Member Moats moved, Member Troehler seconded, that the administration be granted the authority to spread up to \$116,000.00 for salary increases for non-academic staff, and that up to \$12,000.00 be authorized for one-time, non-cumulative pay for outstanding performance.

Upon roll call, the vote was as follows:

Administrative Personnel Salaries, Salary Ranges, and Monetary Fringe Benefits Member Marier moved, Member Troehler seconded, approval of the administrative request for \$70,000.00 to \$91,000.00 (7-9%), to be spread among administrators for general raises and merit considerations, and that the attached proposed administrative salary ranges be approved effective July 1, 1974; further, that administrative contracts for Vice Presidents be extended from two years to three years, and from one year to two years for other administrators, after two years of above average service in the position.

In view of the change to multiple year contracts, Dr. Lahti suggested having counsel review the contracts for any language change. Member Moats felt approval of the extension of administrative contracts should be postponed until after review by Attorney Hines. Member Marier, with the agreement of the seconder, withdrew her motion.

NEW BUSINESS: Administrative Personnel Salaries, Salary Ranges, and Monetary Fringe Benefits (cont.) Member Marier moved, Member Troehler seconded, approval of the administrative request for \$70,000.00 to \$91,000.00 (7-9%), to be spread among administrators for general raises and merit considerations, and that the attached proposed administrative salary ranges be approved effective July 1, 1974. Chairman Kelly directed Dr. Lahti to obtain an opinion from Frank Hines on any language changes in the multiple year contracts, and Dr. Lahti stated this would be mailed to the Board and ready for action at the June Board meeting.

Teaching and Counseling Associates Salaries and Monetary Fringe Benefits Member Munson moved, Member Rausch seconded, that salaries of teaching and counseling associates be increased by 9.2% of the 1973-1974 salaries; that based on the evaluations of their performances a one-time, non-cumulative payment, not to exceed 5%, be awarded to those associates who are identified as outstanding performers; and that salary ranges should be adjusted by 6.2% to reflect inflation. The new range would be \$5,400 to \$9,800 a year for a 10 month appointment, based on a 37% hour work week.
