## Art Liberation



**Eugenia Makowski discovered and pursued her passion for art at Harper College.**

**Paul and Eugenia Makowski's** 58 years of marriage started shortly after World War II. As Paul tells it, they were both graduates of the Nazi education system. Eugenia was interned in a labor camp while Paul, a member of the Polish Resistance, was imprisoned at the Buchenwald concentration camp. "Eugenia saw what I looked like when I was liberated from Buchenwald," said Paul. "She was deeply interested in my experience at

the concentration camp." That experience would inspire several sculptures later in her career—pieces that explore and explain the palpable pain of death and devastation while celebrating the strength and triumph of the human spirit.

After World War II, the Makowskis moved to the United States, and Paul began work with a large corporation outside of the Cleveland area, raising two children. When they became empty nesters in the 1970s, Paul encouraged Eugenia to enroll in classes at the local community college to study "something practical like book-keeping." Eugenia, who had completed her secondary education in the Ukraine and had started teaching grade school before the war, obliged and signed up for a basic accounting class. "One day Eugenia noticed people working on ceramics. At that moment she gave up accounting and decided to work with clay," Paul said. Soon Eugenia was creating large abstract pieces that were displayed at the local library and other public places.

In the early 1980s Paul was transferred to Chicago, and Eugenia was reluctant to move. Paul traveled to his company's headquarters in Rolling Meadows and visited areas where he thought that he and

## Jim McGuire Endowed Scholarship

Harper student **Ying Qin** has been awarded the first **Jim McGuire** scholarship of 2005. The fund, which was established following McGuire's death in 2001 by his friends and colleagues at Accenture, supports students enrolled in Harper's IT program. **Kurt Olson**, who worked with McGuire at Accenture (then Andersen Consulting), and co-worker, **Tim Hobbs**, organized a successful golf outing in September 2002 that included numerous friends of McGuire. They used the event proceeds to establish an endowed scholarship at Harper in memory of their friend. Each year Olson has helped organize the event and increased the amount of the endowment, which is now almost \$20,000.

McGuire led a training function for 10,000 people at Accenture before he decided to change his career, take a 90 percent pay cut and start teaching. He had traveled the world and held lucrative positions in business, but McGuire was passionate about teaching. McGuire's new career was just beginning when he was killed in a car accident in 2001.

The Jim McGuire Endowed Scholarship at Harper will serve as a living testament to the successful, professional, inspired teacher and friend who defied convention and followed his passion.

Her inspiring teaching style helped launch the careers of professional actors who began their performing careers on Harper's stage.

Although she is "retired," Willis' passion for her craft keeps her teaching at Harper, where she also directed the 2005 spring play, *The Imaginary Invalid*. She continues to demonstrate her passion for education, students and Harper in her volunteer leadership roles at the Foundation and her continuing generosity. In 2004 Willis established an endowed scholarship in support of new or returning Harper students who have demonstrated a commitment to theater through course work and/or production experience. The scholarship will help offset the cost of tuition, books or expenses for the student(s) selected.

"During my career at Harper I had the privilege of sharing in the lives of many wonderful students. This scholarship is a way to thank all of those students for the gifts they were in my life. I'm also honoring what has been most important to my life—the essential role that the arts play in the education of the individual," Willis said.

The Mary Jo Willis Theatre Scholarship will be awarded for the first time in fall 2005. **Laura Pulio Colbert**, after consultation with theater faculty, will choose the recipient from a pool of qualified candidates.



**Jennifer Spencer** was a Distinguished Scholar at Harper College, a prestigious award given to students who graduate in the top 10 percent of their high school class. Spencer completed her degree at Harper in two years and is a high school science teacher today because someone believed in her ability to learn and succeed. Just a few years after leaving Harper, Spencer is already giving back. In mid-2004 she established the Bright Futures Scholarship, to benefit full-time students who are pursuing a Harper degree. "My goal was always to give back to Harper and to provide someone else with what I had while I was a student," she said. "My parents always donated 10 percent of their income to their church, so I wanted to give back. Spencer transferred to Carthage College after finishing her studies at Harper. She earned her teaching degree and joined Tremper High School in Kenosha, Wis., teaching U.S history to ninth and 10th grade students and psychology to 11th and 12th graders. She sets aside a small portion of her paycheck each pay period to support the Bright Futures Scholarship. "It's nice to know that I am helping someone at Harper—someone who doesn't have to worry about the extra stress of financing college."



Eugenia could live. "Someone from work mentioned to me that I should visit Harper College to meet the art faculty." Paul brought back several brochures about Harper's art program. "Harper became a good selling point for me to get Eugenia to move to Chicago." The Makowskis moved to the Northwest suburbs at the end of 1981. By early 1982 Eugenia had enrolled in her first Harper art course. Soon Eugenia developed her own artistic style that went beyond throwing pots.

Paul describes Eugenia as blossoming as an artist with guidance from Harper art faculty, **Barbara Cooper** and **Mike Brown**. Her sculptural approach to ceramics and passion for large, abstract pieces that reflected her deep spirituality and love for humanity resulted in numerous awards and accolades. Several area institutions, including Harper College, display Eugenia's work today. Symbolic in nature and rich in meaning, Eugenia's pieces include wooden spiral sculptures like *Ascendare*, on display in front of the Barrington Public Library and *Just a Number*, which Paul keeps at their home, which was one of Eugenia's last pieces she created before her death in March 2004. *Just a Number* includes a copy of Paul's Buchenwald number and the red triangle with the fabric letter P that Paul had to wear indicating that he was a political prisoner. The number and marker are enclosed within a symbolic barred window. "Eugenia understood the horrors of that time were long gone, but that the horrors lived on in the memories of those of us who were still alive—those of us who remember vividly when we were just a number," said Paul.

Harper is home to several of Eugenia's notable pieces including *Scroll and Windows*, a series of seven windows that are gilded in gold on one side and painted black on the other. Paul said the dark side of the windows symbolizes the stifling concentration camp while the gilded side represents hope and freedom. "She thought of the pieces as windows of hope," he said.

When Eugenia passed away last year several of her friends recommended that Paul and his family memorialize her at Harper. "I was too distraught to even think about it," Paul said. "Until Eugenia's friend Olga, who was a bridesmaid at our 1945 wedding, told me that she wanted to send

a donation to Harper College in Eugenia's name." Paul contacted the Educational Foundation and discussed options with his family. "My son and his wife made a \$10,000 gift to establish an endowed scholarship fund in memory of Eugenia. Household International, where Paul and Eugenia's son works, matched the gift with a \$10,000 gift to the fund. Then, numerous friends from across the country began sending gifts to Harper. There is now more than \$20,000 in an endowment that will be used for scholarships and awards for art students at Harper, especially those studying 3-D art.

"When Eugenia passed away we thought about how best to celebrate her life and remember her. We discussed a monument at the cemetery, and we agreed that she should be laid to rest in a quiet spot in St. Michael's Cemetery that overlooks Harper. We purchased a modest marker for this spot because we thought that the true monument to Eugenia would be a perpetual gift to Harper art students."

A beautiful woman with a wonderful, generous spirit and a gift for art, Eugenia Makowski was a treasure to Harper's faculty and students. Her artwork will continue to inspire future artists while her family's generous scholarship fund, named in her honor, will encourage budding artists to explore and refine their artistic talents.

# In Memoriam

## **Harper mourns loss of beloved college president (1978-1988) James J. McGrath**

Former Harper College president **James J. McGrath** passed away in December 2004 in Pennsylvania at the age of 73.

McGrath, formerly of Palatine, was Harper's president from 1978 to 1988. A warm and outgoing individual, McGrath brought to Harper a focus on academic excellence that is the College's hallmark today. "He emphasized the importance of a top-quality faculty, both in the initial hiring criteria, but also through giving them opportunities for sabbaticals and attending conferences to grow academically," said **Kris Howard**, a longtime Harper Board trustee, in a December *Chicago Tribune* article.

McGrath focused on increasing Harper's academic reputation and immediately started an academic convocation that was held before commencement to recognize high-achieving students. "He encouraged us to be a community of scholars," said **Mary Jo Willis**, a former director of theater and professor of speech and theater at Harper. "It was just a privilege to serve during his tenure because he was such an inspiration."

McGrath also oversaw landscaping on campus. He helped transform a pasture into a beautiful sprawling, green campus. Passionate about teaching, McGrath continued to lead an accounting class during his presidency, and he was known to hold casual conversations about Shakespeare over a pot of tea at his home with students and staff members.



An inspiring leader and teacher, mentor and friend, McGrath will be deeply missed.

## **Nicklas force behind Harper College**

**Jessalyn Nicklas**, one of the first Harper College board of trustee members and co-founder of Harper College, died Feb. 25 of complications from asthma. She was 89.

"She was a dynamic woman who was well educated and one of those individuals who was always interested in everything," said Kris Howard, a Harper College trustee, in a March 5 *Daily Herald* article. "She felt we really didn't have an institution of higher education close to the burgeoning Northwest suburbs."

When the idea of a community college failed to pass in the 1960s, Nicklas lobbied leaders in Wheeling, Palatine, Elk Grove and Schaumburg townships to present another referendum to the community. When the community approved the referendum, Nicklas served as a trustee from 1965 to 1979. She also co-founded the Illinois Community College Trustees Association and was community liaison to the Illinois Board of Higher Education for eight years.

"Of all the trustees, there was no one who was more dedicated or spent more time and energy on behalf of the community for the promotion and development of Harper College than Jessalyn Nicklas," said **Robert Lahti**, Harper's founding president, in a March 4 *Chicago Tribune* article.

"I bequeath to the William Rainey Harper College Educational Foundation, a corporation duly existing under the laws of the State of Illinois, and located in the Village of Palatine in said State, the sum of \_\_\_\_\_ (\$ ) Dollars to be used for the purposes of establishing an endowed scholarship as set forth in the Fund Agreement as executed by me and the William Rainey Harper College Educational Foundation and which is incorporated herein by reference."

By including that one paragraph and funding it with a minimum of \$10,000, you can have the satisfaction of knowing that you have created a lasting legacy. You also can enjoy the benefits during your lifetime. You can name the scholarship as you wish. You can become a member of the Harper Heritage Society, and see your name on the donor wall in the lobby of the Performing Arts Center. Like the Makowski family and Mary Jo Willis, you can help students go forward and realize their goals.

Beese serves in a leadership capacity in numerous community organizations throughout Barrington. Her special interest has been the development of Ron Beese Park, an 85-acre park named after her late husband. She is the mother of two children, and she has four grandchildren.



### Rita Canning

Rita Canning is the founder of the Palatine Home of the Sparrow, which operates transitional shelter programs for abused and homeless women and their children. She opened a large resale shop for the nonprofit organization, Women in Need Growing Stronger (WINGS), and she established the first domestic violence shelter in Chicago's Northwest suburbs.

Canning serves as the vice president of the Canning Foundation, which funds programs like the Canning Scholars that provides scholarships to more than 100 inner-city children in six private elementary and secondary schools. She helped

create and continues to fund the Holy Angels Outreach Program that provides assistance to residents of the Ida B. Wells homes. She is an active volunteer and serves as a member of the Women's Board of Northwestern University and the

Field Museum. She also is a member of the State Treasurer's Strategy Board for Women's Economic Empowerment, a director of Harris-Bank Palatine and the Buehler YMCA, treasurer of the Northwest Suburban Alliance on Domestic Violence, and she serves on the Steering Committee of the Circuit Court of Cook County—Third District, Family Violence Coordinating Council.

Canning graduated from the University of Illinois, Champaign, with a bachelor's degree from the College of Commerce and Business Administration.

She and her husband, John, live in Inverness and have six children.



### Diane Hill

Diane Hill recently retired from Northwestern University where she served for 32 years as senior lecturer, author and clinical supervisor in speech and language pathology. She presently partici-

pates actively with her husband, David Hill, CEO of Kimball Hill Homes, a nationally known homebuilder based in Rolling Meadows.

She was a charter member and served as chair of the Specialty Board on Fluency Disorders, has held numerous leadership roles for All Saints Lutheran Church in Palatine and is a member of the Leadership Committee of the Fund for Leaders in Mission of Evangelical Lutheran Church in America. 





# Art on Campus Artward Bound
