# 'Project Tomorrow' Campaign Provides Bright Future

**On Friday, August 22nd, the Harper College Educational Foundation hosted an "Evening by the Pond" to launch the public phase of its ambitious Project Tomorrow:**

**The Power of Community** major gifts fundraising campaign. While rain forced the event indoors to the Avanté Center, nothing could dampen the spirits of attendees who share a commitment to supporting the campaign which aims to build student scholarships, support faculty enrichment and seek funds to bolster dozens of programs. In the two years since the quiet phase of the campaign started, over \$7 million has already been

raised, with 100 percent of the College Trustees and members of the Foundation Board of Directors generously contributing.

As the campaign enters the public phase, it is important to note that the case for support of the campaign was designed based on input from Harper's community - both internal and external. Community members, public servants and area business leaders provided an assessment of workforce needs with those of College deans, program directors, faculty and students. This resulted in 13 primary areas of focus for the campaign, which is schedule to continue through June 2009.

# Rita and John Canning Pledge \$500,000 to the Women's Program

Tragically, domestic violence has been characterized as an epidemic in Illinois. Recent figures indicate that within the 23 municipalities of Harper College District 512 alone, 2,130 domestic offenses were reported to Illinois State Police in 2005 according to the Illinois Criminal Justice Information Authority. Sadly, there is a fear that the number may be even higher as under-reporting of these crimes is suspected. In the face of these disturbing figures, Harper College has long been committed to helping abuse victims through its renowned Women's Program.

On September 9th, the program was formally renamed "**The Rita and John Canning Women's Program at Harper College**" in recognition of the Cannings long-term commitment and support of \$500,000 for women in need. The Cannings most recent gift to the Educational Foundation establishes a generous endowment supporting scholarships for program participants. Additionally, a portion of the gift has been designated to launch a legal assistance pilot program, providing access to valuable resources for program clients.

"Research shows that women who attain an education are better equipped to get out of their abusive relationship. For many women, Harper College provides affordable educational opportunities to those who otherwise might not have had the chance to go beyond high school,"

said Rita Canning."

Vera Davis, who earned three scholarship awards thru the Women's Program, is one of the many success stories. "As a Fast Track student, this was one of the most challenging and rewarding experience of my life. Harper has helped me realize my goals, focus on self-development, and plan for my future. After graduating in December 2008, I plan on attending a four-year university to get my bachelor's degree in business administration, management."

There are many others like Vera who without Harper's Women Program may not have anywhere else to turn for help. Women who have experienced domestic abuse come to the Harper College Women's Program each year for assistance with education and employment so they can end their abusive relationships and support themselves

and their children.

Since 1969, the Women's Program at Harper has been at the forefront of positive change, even inspiring Illinois State Senator Virginia McDonald to sponsor the Displaced Homemakers Act of 1977. In 2006, The Illinois Department of Labor cited the Women's Program as a Model Program among the ten Illinois Support Training & Employment Programs for Displaced Homemakers in the State. In 2007, the Department awarded the Women's Program a Certificate of Excellence for consistently exceeding performance goals.

Speaking on the renaming of the Women's Program, Harper College President Dr. Robert L. Breuder observed, "Through the generosity of the Cannings, the Women's Program will be able to deliver on its mission to provide sound education and employment resources to those most in need. Support from the private sector for this vital program, and others like it, has become increasingly important in light of recent state budget cuts that threaten these programs that benefit the entire community." ■

# In Remembrance of David K. Hill



On July 26, Harper College lost one of its leaders and strongest supporters with the passing of David K. Hill, executive chairman of Kimball Hill Homes and long-time community philanthropist. Mr. Hill was appointed as a Harper Trustee in July of 2004 and was elected to a four-year term in 2005.

Before becoming a trustee, Mr. Hill was an active member of Harper College's Educational Foundation. Along with his wife Diane, the couple were generous contributors to the College's arts programs and took a special interest in Harper's nationally acclaimed programs for the hearing impaired. The charitable couple provided the seed money to start the Kimball Hill Family Deaf Institute and an endowed scholarship fund at Harper in David's memory.

Commenting on Mr. Hill's death, Harper College president Dr. Robert Breuder observed, "David Hill's commitment and affection for Harper was clearly evidenced by his willingness to run for public office on behalf of the College and through his sage advice and philanthropic support. Harper was a great source of pride for David. He believed passionately that higher education should be accessible and affordable to all and devoted his time, energy and resources into making that a reality for the people of the northwest suburbs."

Added Laurie Stone, Harper College Board of Trustees chairperson, "The Harper Board was blessed to work with David. We benefited from his vast knowledge, insightful questions, creative suggestions and sense of humor. We will miss him dearly."

Mr. Hill's efforts on behalf of Harper College will benefit current and future students for years to come. Memorial donations can be made to the Harper College Educational Foundation earmarked for the David K. Hill Memorial Fund. ■




# Motorola Award for Excellence Winners

Since 1981, Motorola has sponsored its Award for Excellence, which is the highest honor a Harper College student or faculty member can earn. The Award honors a student who has demonstrated outstanding achievement in academics, extracurricular activities and community service, while attending Harper College. Application for this scholarship is open to students from all College degree programs who exhibit exemplary achievement in the areas of academics, community service, leadership and extracurricular activities.

Last year, Motorola committed to sponsoring two Award for Excellence scholarships which are awarded to a traditional aged student—one who is 23 or younger, and to a non-traditional student—one who is 24 or older. This year's recipients of the Motorola Award for Excellence, given through the Harper College Educational Foundation were **Kim Cozzi** in the traditional category and **Rogelio Ramirez** in the non-traditional category. These students will receive awards for \$3000 each (\$1500 per student, each semester).

**Dr. Julie Ellefson-Keuhn**, Harper College associate professor of chemistry received the Motorola Faculty Award for Excellence. In presenting Dr. Ellefson-Keuhn with the prestigious award at the May commencement ceremony, Harper College President, Dr. Breuder pointed out that Ellefson-Keuhn has been a teacher, counselor, mentor, and friend to her students and colleagues for 22 years. He stressed that because of her dedication, Harper students benefit from a curriculum that is current and relevant to their studies and prepares them for a lifetime of learning. As Dr. Ellefson-Keuhn received the thanks of the Foundation Board in September, she commented, "I love my job! It's a joy to help students to appreciate the beauty of chemistry."

## Otter Chemistry Endowment Offers Formula for Success

Harper's chemistry department was recently named the College's first Center of Excellence in recognition of its commitment to supporting students in their pursuit of exceptional academic achievement in the classroom and the chemistry field overall. To help students even more, chemistry professor Jayne Wilcox and her husband Bob established the Otter Chemistry Endowment over 15 years ago.

"We chose to establish the Otter Fund as a way to give back to education, a career Jayne has loved, and to support Harper College, where she feels she has had exceptional experiences with students and colleagues," explained Bob Wilcox. "We feel that, sometimes, all a student needs is a little encouragement and recognition to instill the confidence necessary for academic success." This confidence often spills over into other facets of their lives. The Educational Foundation helped us from the very beginning to design a fund that would accomplish our goal of being able to reward several students each semester for their hard work."

Funds from the Otter Chemistry Endowment can be used for chemistry students in three different ways. First, money may be allocated as needed for students to attend and participate in regional or local conferences held by professional organizations. Within the chemistry department, competitions among students on special projects are sometimes held and small cash or merchandise prizes may be provided from the Endowment. Lastly, cash incentive awards are given to selected students at the close of each spring and fall semester.

Through these incentive awards, the Otter Chemistry Endowment recognizes students who demonstrate exceptional scholarly attributes. Award winners are nominated by their instructors for a variety of reasons, including self-discipline, motivation, perseverance, generosity towards classmates, and academic performance. Students need not have the highest grade in their chemistry class, but only demonstrate an attitude toward their studies that is honorable, well-intentioned, and inspirational to both their classmates and instructors. ■

## Open Book Scholarship Gets Great Reviews

For the past 19 and 21 years respectively, **Dr. Chris Poziemski** and **Dr. Jean-Louise Gustafson** have changed lives as highly respected faculty members in Harper's Department of Academic Success. Having been a part of the College and its students for so long, it seemed only natural that they would not let their retirements in July 2008 keep them from continuing to make a difference in students' lives. When they announced that they were establishing the Open Book Scholarship with the Educational Foundation, additional contributions were made to the fund by other faculty members, an indication of the high regard they are held in by their colleagues.

The Open Book Scholarship will award \$500 each spring and fall semester to a deserving student who has completed Reading 099 and performed well in the successive semester. Reading 099 provides classroom instruction in comprehension utilizing a wide variety of written materials for students who need assistance in bringing their reading skills to the college level. By having the requirement of achieving ongoing academic success, the hope is that the scholarship will serve as motivation for those who do not always have the opportunity to qualify for academic awards.

As Dr. Poziemski explained, "The scholarship was started to encourage students to achieve academic excellence while they experience college level

reading, engage in critical thinking, and improve their reading comprehension for future academic successes. It was also a way for us to give back to the students and the College we enjoyed working with for so many years."

The first scholarship to be awarded will be applied to the fall 2009 semester. A faculty committee overseen by Judy Kulchawik, Chair of the Department of Academic Success, will develop specific requirements for evaluation of potential scholarship winners. While details of the scholarship are being refined, one thing that is clear is that thanks to Drs. Gustafson and Poziemski, students who may not have seen academics as a path to success now have new doors opened to them. ■

## Resource For Excellence Grant Provides Start Up Funds for the Illinois Small Business Development Center at Harper

A recipient of a 2008/2009 Resource For Excellence grant from the Harper College Educational Foundation, Harper's Small Business Development Center held an open house on September 10th to launch their services and share capabilities with the local business community.

The mission of the Center is to contribute to the growth and prosperity of existing businesses in the early stages of development and improve the success rate of new business start-ups. The Center also helps existing small businesses by providing strategies for growth and expansion. In addition to the start-up funding received through the Educational Foundation, the IL SBDC is funded in part through a cooperative agreement with the U.S. Small Business Administration and the Department of Commerce and Economic Opportunity to help the 33,000+ businesses (95% of them small businesses) operating within Harper's district to start, grow, expand, and prosper.

The Illinois Small Business Development Center offers no-cost, one-on-one confidential guidance to clients on a wide array of topics, include:

- Business start-up assistance
- Opportunity assessment
- Business planning
- Market research and plan development
- Management and operations
- Finance and accounting
- General business management issues

Since the Center opened in February 2008, they have counseled 175 clients for more than 550 counseling hours. Clients have been successful in obtaining more than \$700,000 in financing and creating more than 70 local jobs.

Commenting on the program's success, IL SBDC director Bonnie Richter said, "Working closely with area companies helps create a mutually beneficial partnership between the business world and Harper College that allows everyone involved to achieve greater levels of success."

The Illinois Small Business Development Center is a perfect example of how our donor's dollars are invested to advance and support student and community success. ■

## Recent Donations Begin to Answer Public Safety Program's Call for Help

For many years, Harper College has offered a public safety programs that have prepared hundreds of EMT/paramedics, fire and law enforcement professionals for the challenges of a demanding and vital career. Given that these public servants operate in situations with little margin for error, it is critical that they have access to the latest training and equipment resources. One of our focuses through the Project Tomorrow major gifts campaign is to generate support to augment our training program offering locally for our safety and enforcement professionals, setting the standard for others to follow. We are pleased to share that we have received a gift to help in launching us on this path.

**ID Networks**, a veteran records management and identification technologies company for the criminal justice market, has generously committed an included gift of equipment and software. Their state-of-the-art dispatching equipment, utilized by many E911 centers across the country, will be used to train dispatchers locally at Harper. Prior to this, local communities had to send their dispatcher trainees out of state for training or they relied on on-the-job training. Neither option was ideal as these approaches were a drain on resources. Additionally, having access to this type of equipment improves the quality of the learning experience and allows newly minted dispatchers to do their jobs more effectively, resulting in greater public safety.

Harper is committed to serving the needs of the district and its residents. Thanks to the generosity of this donor, we have taken a step toward realizing this vision in the public health and safety arena. ■
