EVERYTHING OLD IS NEW AGAIN

Harper College celebrated the reopening of one of its six original buildings after a renovation transformed the 1969-era structure into a state-of-the-art learning environment.

More than 200 people gathered in the Building D rotunda, now known as the Beaubien Family Rotunda, on August 18, 2016 for a dedication ceremony.

Funded by capital referendum dollars approved by District 512 residents, the 18-month, \$44.8 million project was delivered on time and under budget.

The centerpiece of Building D is a two-story, glass rotunda that creates an inviting place for students to meet, study and learn. It's known as the Beaubien Family Rotunda in recognition of Educational Foundation Board member Dee Beaubien and her family's gift to support Harper's Promise program.

"Dee and her family have made an investment in Promise, but more than that, they've become champions of the program," Harper College President Dr. Ken Ender said.



HOPE GIVING CIRCLE AWARDS INAUGURAL \$10,000 SCHOLARSHIP

Kayla Karbowski considers herself pretty fortunate; after all, she's found her calling at just 19 years old. The second-year Harper College student has no doubt she's meant to work with individuals who have special needs, a realization she came to over the past year working at the Northwest Special Recreation Association.

"The organization has shown me the difference I can make in a person's life and the enjoyment I get from working with children and adults with special needs," Karbowski, of Schaumburg, said. "To me, it doesn't feel like working."

Karbowski's commitment to helping others—on top of a 4.0 GPA and induction to the Phi Theta Kappa honors society—made her the natural choice for the HOPE Giving Circle's inaugural \$10,000 scholarship.

The Harper College Educational Foundation recently formed the HOPE (Helping Others through the Power of Education) Giving Circle to connect charitable-minded women with a common goal of empowering women to reach their full potential. The program provides financial support, ongoing mentoring and leadership development for female students who are completing their final year at Harper and continuing on to a four-year college.

HOPE Giving Circle members recognized Karbowski on July 19 at a reception at Bridges of Poplar Creek Country Club in Hoffman Estates.

Once she graduates from Harper next spring, Karbowski plans to put the balance of the scholarship toward tuition at Illinois State University, where she hopes to double major in elementary and special education.

"This is a very substantial scholarship that makes a bachelor's degree more accessible and affordable," said Kathy Gilmer of the HOPE Scholarship Awards Committee. Gilmer described the scholarship selection process as competitive. Karbowski, she said, rose to the top because of the passion for what she's doing.

In addition to working part time at the NWSRA, Karbowski, who graduated from Schaumburg High School in 2015, dedicates every weekend to volunteering at Elite Stars, a special needs athletic and

recreational program. She serves as a head ice skating coach and peer gymnastics coach, mostly to people with Down syndrome.

Karbowski also volunteers at the Almost Home Foundation, a local animal rescue organization.

The youngest of three children, Karbowski said the scholarship helps to ease a tremendous financial burden from her family.

"Now I can focus more on obtaining my education rather than figuring out how I'm going to pay for it," she said.

WHERE ARE THEY NOW?



During this past summer, Jori worked two jobs in addition to taking three online classes while volunteering at the Northern Illinois Foodbank, Special Olympics events and Midwest Center for Children. Jori writes, "I love helping people and can't wait to continue helping people through my future career as a dental hygienist."

She started the Dental Hygiene program this fall, and will not be able to work as much due to the intense workload. The Donna Penkava Grzegorek Dental Hygiene Endowed Scholarship will help relieve Jori of some of her financial burdens by helping to pay for extra program expenses of instruments, books and supplies like gloves, masks, lab coats, scrubs and shoes.

HARPER RECEIVES GRANT FROM BARRINGTON AREA COMMUNITY FOUNDATION

The Harper College Educational Foundation received its first grant from the Barrington Area Community Foundation (BACF) to help expand outreach to Barrington Area middle schools. Currently, District 220 engages with Harper College through the Promise Scholarship and the Ambassador Schools programs.

This new partnership with BACF will provide the first opportunity for Harper to work closely with the two Barrington Area Middle Schools to create programming with the intent of impacting college readiness. Representatives from Harper College and District 220 held meetings in late spring and throughout the summer to lay the groundwork to offer pilot programs during the upcoming school year.

During the 2015–2016 school year, more than half of the freshman class at Barrington High School signed up for the Promise Scholarship program. This program offers students the opportunity to earn tuition at Harper by meeting benchmarks during high school.

RESOURCE FOR EXCELLENCE GRANT HIGHLIGHT: INZONE ACCESS PROGRAM | SUMMER 2016



This summer, Harper's InZone program teamed up with the Harper College Educational Foundation and Wheeling's Community Consolidated School District 21 to provide fun and educational opportunities for children who experience housing instability.

InZone is Harper's youth summer enrichment and sports camp. Beyond a day camp, InZone provides students with a college campus experience. Studies show that young people generally make the decision to attend college before they enter high school.

As such, 20 elementary and middle school students were chosen for the program from District 21 based on their family's low-income status and housing instability. Housing instability is "variably defined

as having difficulty paying rent, spending more than 50 percent of household income on housing, having frequent moves, living in overcrowded conditions or doubling up with friends and relatives."

Because housing instability can have a negative impact on academic performance*, the program is designed as a learning experience to inspire students to attend college.

Families work with the school district and InZone staff to select from a range of classes that include launching a rocket, dunking a basketball, learning to cook or mastering math challenges. In addition, students are provided with lunch.

Students were shown that Harper is a viable option to getting a college education. They learned about the Promise Scholarship and even had lunch with Dr. Ender. One student in the program said, "My mom and I decided we really need a house and we are going to put all our money towards that. This program lets me go to camp and not have a boring summer."

85 percent of the last year's eighth grade InZone Access participants enrolled in the Promise Program, which is 18 points higher than the overall enrollment rate.

generosity and commitment to the program and thank them on behalf of the students who will benefit from their investment.

The Promise program, created through collaboration with Harper College, High School Districts 211, 214 and 220 and local business leaders aims to make college affordable by offering free tuition to students who have earned it. Eligible to sign up during their freshman year of high school, students must meet requirements focusing on attendance, graduation, grades, college readiness and community

service while in high school. If the criteria is met, students will earn one free semester tuition at Harper College. Students can continue earning free tuition if they meet similar criteria while enrolled at Harper. All in all, students can earn up to 60 free credit hours at Harper College.

CORPORATE INTERNSHIPS LEAD TO JOB OPPORTUNITIES

Northrop Grumman is building on Harper's advanced manufacturing program by providing students with real-world experience and opportunities to apply what they have learned and grow their skills.

"Our partnership with area manufacturers has been a tremendous success, not only in helping us develop the program's curriculum, but also in giving students real work experience on the manufacturing floor," said Harper College President Dr. Kenneth L. Ender. "Together, we are making substantial progress in building a pipeline of highly skilled workers to meet the needs of 21st Century manufacturing."

Nine students have completed the internship program since its inception in the fall 2015. The 12-week experience provides them with the opportunity to apply what they learn in the classroom to a real-world setting.

So far, eight students have been offered full-time positions with Northrop Grumman upon completion of their associate degrees at Harper College.

Keith Brewer, one of the eight who was offered employment reflects on the internship, "The biggest surprise for me was getting a good job offer from the Northrop Grumman Internship. Harper helped me find this internship and it has been amazing," said Brewer. "I also love the hands-on learning in the advanced manufacturing program."

"Our partnership with Harper is critical to the future of our manufacturing operation. We have a strategic approach to developing a pipeline of talent for the future in a highly competitive market. Partnerships between academia and industry are critical to this strategy. Having this local pipeline of highly-trained graduates has been extremely valuable to our company. We're so pleased with the talent coming out of the program."

Northrop Grumman executives and Rep. Tammy Duckworth toured Harper's Advanced Manufacturing Program which was developed to train students for good-paying manufacturing jobs in the Chicago area. The program partners with 70 area manufacturers that offer paid internships and apprenticeships to go along with rigorous classroom training in fields such as precision machining, mechatronics/automation, metal fabrication, welding and supply chain management.

GRANTS HELP SUPPORT HARPER'S MILITARY-CONNECTED STUDENTS

Harper College recently embarked on a new initiative to better serve our military-connected students. During the last 18 months, Harper College's Veterans Task Force has been instrumental in fostering a supportive educational environment for military-connected students, including the reinvention of the Student Veterans Association (SVA).

This fall, the new Center for Student Veterans and Military-Connected Students will open and will provide services to military-connected students (veterans, active-duty/reservists, and eligible dependents) and to assist in the social transition from service to civilian life.

Because of their hard work and dedication, the Student Veterans Association has been awarded two grants, one from an anonymous private foundation and another through the Student Veteran's Association. These grants will create stronger links both within the institution and with services outside of Harper to better serve Harper College's military-connected population.

Because of the private foundation grant, two Harper veteran students and one Harper staff member traveled to the White House in Washington D.C. to attend a presentation regarding military-connected research from the Community College Research Center at Columbia. In addition to the visits with congressional leaders, Harper's group also attended a meeting with the Student Veterans of America, the Iraq and Afghanistan Veterans of America (IAVA), and the Young Invincibles groups to discuss ways that veterans can become involved to connect service members across the nation.

Currently Harper serves an average of 300-400 veterans and eligible dependents per semester. It is anticipated with the new Center, and support from private foundations, that Harper will increase its reach into the veteran student population in our community and become a sought out institution specifically because of these efforts.

THE SCHAUMBURG/ HOFFMAN ESTATES ROTARY

The Rotary Club of Schaumburg/Hoffman Estates created the Fishing Well Scholarship to support adult students living or working in Schaumburg Township who are pursuing a degree or certificate program. Designed to support adult students who are overcoming challenges in their life, the Fishing Well Scholarship will specifically serve students who are enrolled in Harper's ESL program, HSE (High School Equivalency) Program, Career Bridge Program, Fast Track Program or the Rita and John Canning Women's Program.

The Rotary Club of Schaumburg/Hoffman Estates is building on their already existing relationships with the Palatine Opportunity Center, WINGS, Kenneth Young Center and other community service agencies by offering preference to those students who have received referrals and references from these existing organizations to Harper College.


The \$200,000 scholarship will provide \$25,000 in funding annually and the Club's intention is to grow the scholarship exponentially over the next few years. The Rotary Club of Schaumburg/Hoffman Estates will offer mentoring opportunities for the Fishing Well scholarship recipients.

The first 10 inaugural recipients of the Fishing Well Scholarship include students studying computer science, human services, sonography and English as a Second Language. In addition, several recipients are earning certificates in the office assistant, phlebotomy and emergency medical technician programs.
