# Fulfilling a Promise

This May, Harper College celebrated its first class of 140 graduating Promise students. These hardworking students enrolled in the Promise Program in December 2015. For the last six years, they have dedicated themselves to earning strong grades, demonstrating college readiness, maintaining good attendance and serving their communities. In return, they were guaranteed the opportunity to earn two years of tuition at Harper College. During the COVID-19 pandemic, Promise students demonstrated they are not only academically excellent, they are flexible and determined as well.

Despite the unique challenges these students faced, Class of 2021 Promise Scholar **Arij Ahmed** reports, "I know I made the right decision...The Promise Program is a reminder in my life that there's always something better than you were looking for. You just have to go out there and find it first." Arij is one of the 78.5% of the Class of

2021 Promise Scholars who plan on transferring to another institution to pursue their bachelor's degree. Another 5.4% reported that they will be seeking employment following graduation, whereas the remainder have a range of plans from seeking an internship to starting their own businesses.

**Gurveen Lally**, another Promise Scholar member of the Class of 2021, offers her gratitude saying, "Thank you to all the donors for giving other Promise students and me the opportunity to obtain a college education. Your generosity does not go unnoticed." She notes that her time in the Promise Program profoundly impacted her skills as a student and made her a more well-rounded person. She shares her advice to future Promise students: "This is an opportunity to experience college without having to worry about how you can afford it. Take advantage of it and shape the kind of student you want to become."

Congratulations to the Promise Class of 2021 and to the many donors who contributed to the Promise program. Donations were first accepted for the Promise program starting in 2014, long before a Promise student enrolled at Harper. We are grateful for our donors' belief in the program and their support of students in our community. Thanks to your generosity, 140 students are graduating from Harper debt-free with six years of experience in setting and attaining goals and a bright future ahead.

# From Excel Beyond 211 to Harper, a partnership to success

This August, **Danica Lopez** will earn her Associate in Applied Science for Diagnostic Sonography from Harper College. Danica's resilience has served her well while pursuing a college education during a pandemic. She also credits the generosity of scholarship donors to helping her achieve her goal. "I definitely would not be where I am now without the help of scholarship donors. I have worked since I was 17, and it hasn't always been easy. Unfortunately, my family was not able to cover school costs. For years I have been balancing going to school and working. 2020 was a hard time for me because I had my work hours cut due to the pandemic. My whole plan was to put away as much money as I could before I inevitably had to stop working while I started clinicals."

Danica, the first in her family to attend college, was encouraged by her parents to pursue higher education, but Danica found she needed more guidance as she navigated her path. As a Palatine High School graduate, Danica was a part of Excel Beyond 211 (EB211), an all-volunteer, not-for-profit organization founded by Harper Trustee and retired District 211 Superintendent **Nancy Robb**. Excel Beyond 211 provides personalized mentoring and college success strategies to selected first-generation college students. Danica was a part of the first class of EB211 scholars. As a scholar, she was assigned a mentor — a guidance counselor at Barrington High School (and a first-generation college student) who was instrumental in helping Danica select Harper as the best choice for her education.

This past year, Nancy and her husband John created the **Nancy and John Robb Scholarship** through the Harper College Educational Foundation to support EB211 participants attending Harper who need support with tuition and fees. Danica is the scholarship's inaugural recipient. When Nancy learned who her first scholarship recipient was, she shared, "You made my day! Danica is very bright and is a great kid. I know what a struggle it has been for her to continue her education. I am thrilled that she is going to graduate this August."

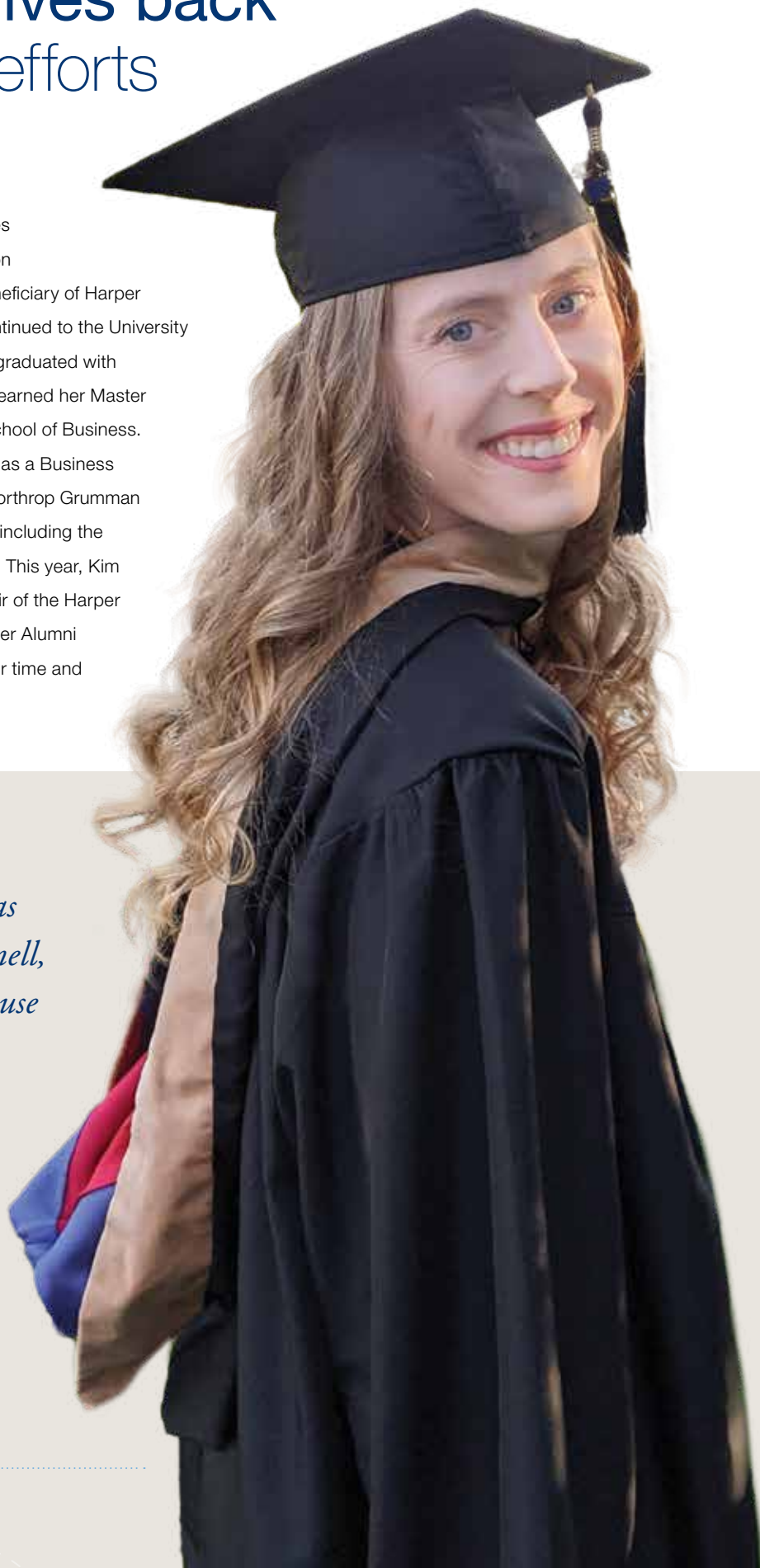

# Resource for Excellence Grants: Inspiring innovation

Through **Resource for Excellence (RFE) Grants**, the Harper College Educational Foundation encourages innovation and creativity among Harper faculty and staff. Funded by donations to the Harper College Educational Foundation, RFE grants are awarded through an annual competitive process and selected by the Educational Foundation Board of Directors. Since the inception of RFE grants in 1993, more than \$1.8 million has been awarded to more than 200 innovative projects at Harper College.

Since its inception of RFE grants, **\$1.8 million** has been awarded to **more than 200** innovative Harper College **projects**. This year, **five projects received \$66,000** in grants from the Harper College Educational Foundation.

One of the Resource for Excellence Grants program goals is to demonstrate successful outcomes of new programs so the college will identify permanent funding for the project. After RFE funding allowed the Alumni program to purchase the Harper Connect online networking platform two years ago, more than 300 alumni have signed up with 76% willing to help connect and mentor Harper students and fellow alumni. Philanthropic giving from alumni has increased since Harper Connect was implemented, and the platform is used for virtual mentoring. With these laudable outcomes, the college has now institutionalized the program.

## The FY22 awards include:

- **Service-Learning Initiative** — Research best practices to create a Service-Learning Program at Harper, with a coordinated strategy for developing, promoting and maintaining service-learning courses and the community partnerships necessary to sustain them.
- **Additive Manufacturing Camps** — Create a pathway for underserved high school students to Harper's Additive Manufacturing program and provide the students with a transformative experience to build their confidence and skills to pursue technical career paths.
- **Disability Cultural Programming** — Foster the campus community's understanding of disability cultural concepts. Encourage the recognition of the disability community as a valued element of diversity to create a more inclusive campus environment resulting in increased engagement and improved retention and completion rates of students with disabilities.
- **Teaching Small Unmanned Aerial Systems (sUAS)** — Complete the development of comprehensive sUAS course of study in the Drone Technology and Applications Certificate by adding the teaching of fixed wings sUAS, and providing professional development for Harper faculty developing fixed wings sUAS curriculum materials.
- **Saving Our Planet from Plastic Waste** — Create a 3D printer plastic recycling program to reduce waste entering the landfill and enhance student learning with purposeful project-based learning experiences and reduce material costs for students.

## Women at the Table event celebrated women breaking barriers

In April, HOPE Giving Circle donors, supporters and friends gathered virtually to hear from a panel of female leaders who have broken barriers in their respective fields at the fifth annual Women at the Table Panel Discussion.

The panel included: **Martha Bell**, Managing Principal, Tilton, Kelly + Bell, LLC; **Monica Mueller**, Vice President of Government Affairs, Motorola Solutions and **Nicole Wolter**, President and CEO, HM Manufacturing, all of whom have carved out careers in traditionally male-dominated fields. The discussion was moderated by

Harper College President **Dr. Avis Proctor** and covered topics such as developing a leadership style, the importance of mentoring relationships and being a female charting a career in male-dominated fields or industries.

Since the HOPE Giving Circle was formed in 2015, the women's affinity group has raised over \$200,000 in funds and awarded \$10,000 scholarships to 14 young women to pay for their education at Harper and their transfer school. The group hosts quarterly events to promote professional development, networking and social engagement.

### THE HOPE GIVING CIRCLE AT HARPER COLLEGE

The HOPE Giving Circle has continued its mission of providing scholarships, mentoring, and networking opportunities to females pursuing their degrees at Harper College and beyond. During the 2020-2021 academic year, HOPE marked \$140,000 in scholarships awarded to date and since the program launched in 2016. Recipients can utilize the \$10,000 scholarship while at Harper College or their four-year transfer institution. ## Advancing Harper's educational initiatives in public safety, technology and engineering

Since 1981, the **Motorola Solutions Foundation** has sponsored its Award for Excellence, which is the highest honor a Harper College student can earn. The Award honors a student who has demonstrated outstanding achievement in STEM, information technology or public safety academics, extracurricular activities and community service while attending Harper College. This year's recipients of the Motorola Solutions Foundation Award for Excellence given through the Harper College Educational Foundation are Stefanie Howard and Antonio Laverd. These students received scholarships for \$5,000 each.

**Stefanie Howard** is pursuing an Associate Degree in Emergency and Disaster Management. She has already completed a certificate in emergency management and public dispatch. After finishing her associate degree, she plans on attending Southern Illinois University for a bachelor's degree with a major in public safety. Stefanie's career goal

is to find a position in the public sector helping the northern Illinois community. Stefanie is an adult, first-generation college student with a 4.0 GPA. She works 40 hours a week while attending classes at Harper.

**Antonio Laverd** is from Arlington Heights and attended Buffalo Grove High School. He is part of the Harper College Engineering Pathways Program, an opportunity for qualifying students to gain admission to The Grainger College of Engineering at the University of Illinois at Urbana-Champaign. Antonio is studying

computer engineering, and he has a 4.0 GPA at Harper.

"I am taking on the burden of my college education alone. It's fair to say I feel quite a bit of pressure from the gravity of a financial investment like college. It has been the best decision of my life to choose Harper. Besides the \$60,000 I am saving, Harper has met and surpassed all my expectations. The coursework is super rigorous. The professors are energetic and care about what they do — making the toughest subjects fun to learn."

## Northrop Grumman and Harper College receive Business/Industry Partnership Award

In June, the Illinois Community College Trustees Association (ICCTA) recognized William Rainey Harper College and **Northrop Grumman Corporation** as the recipients of the ICCTA's 2021 Business/Industry Partnership Award.

Northrop Grumman and Harper College have partnered together to lead the future of work and address the shortage of skilled workers while strengthening the workforce. When Harper reimaged its Advanced Manufacturing program, Northrop Grumman quickly became a vital collaborator in building curriculum, identifying skills competencies, and clarifying industry expectations. They also contributed in the classroom with employees serving as guest lecturers and adjunct faculty while also providing on-the-job internship opportunities for students.

Since the early 1980s, Northrop Grumman has been represented on the Harper Foundation board of directors. In addition, Northrop staff and retirees participate in the Foundation's Alumni, Scholarship, and Finance and Investment committees.

Additionally, Northrop Grumman has supported Harper College students for 40 years with a 2+1 transfer scholarship for engineering students. One of the past scholarship recipients is Harper alum

**Nate Rapp**, who went on to the University of Illinois and became an engineer at Northrop. That path is a bit of a family tradition. Rapp and his five siblings each went to Harper. Of them, two brothers also work at Northrop. "Harper has been pivotal for me, being able to set my career in motion without having to shoulder debt," Rapp said.

Northrop's internship program has provided Harper students with the opportunity to utilize the skills learned in the classroom to real-life experiences. Interns earn a competitive wage and can earn promotions to full-time positions with benefits, including tuition reimbursement. Of the 29 Harper students who have completed an internship with Northrop, 24 were hired full-time.

Harper student **Keith Brewer** received an offer for a full-time position with Northrop Grumman after completing his associate degree. Keith said, "The biggest surprise for me was getting a good job offer from the Northrop Grumman internship. Harper helped me find this internship, and it has been amazing."

Harper College is grateful for the decades-long partnership with Northrop Grumman that benefits our community, local economy and students.

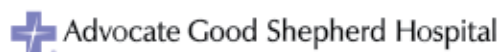

## Motorola Solutions Foundation Distinguished Faculty Award

**Jeff Przybylo** is the 2021 recipient of the Motorola Solutions Distinguished Faculty Award, the highest faculty honor at Harper. Professor Jeff Przybylo believes in empowering the student voice. As a full-time faculty member at Harper College for 25 years, Jeff has mentored students to find and develop their voice and use it to make a difference in the world around them. His drive for classroom innovation to support student learning earned him the Glenn A. Reich Memorial Faculty Award for Instructional Technology in 2007, honoring his creation of a technologically advanced suite of classrooms for student presentations.

In the classroom, Jeff creates a climate that welcomes and engages students and builds their confidence to speak. His latest development of an Intercultural Communication course provides students opportunities to explore a global mindset and learn how to communicate across cultural differences. His pursuit of the discipline includes creating a hybrid speech class more than 12 years ago, spearheading a fully online

speech class years before the pandemic, and expanding the Communication Arts department to include mass communications and journalism curriculum.

In addition to classroom teaching, Jeff has served as the Director of Forensics (Speech and Debate) for the past 25 years, producing a team that consistently places in the top 10 in the nation and boasts dozens of national champions. Over the decades, he has created a family of alumni who will testify to finding competitive and personal success after being a part of the team or the recipient of his direct coaching.

Jeff's energy, creativity and commitment has empowered countless students and colleagues and has contributed to making the Communication Arts department thrive. His dedication to the classroom, speech team, college and the greater community have enriched so many lives and is a testament to his power as a teacher, coach and leader.

## The Professor Powell and Larry Moats Extra Five Minutes Faculty Award



The Professor Powell and Larry Moats Extra Five Minutes Faculty Award was created in 2012 by Larry Moats, a former member of the Harper College Board of Trustees and a Harper Distinguished Alumni Honoree, in memory of his

Harper College mentor, Professor Robert Powell. Professor Powell was a founding faculty member of Harper College and a beloved English teacher and Dean of Liberal Arts. Harper students are asked to submit nominations to recognize teachers that have inspired them, given them extra time, and made a difference in their lives.

**Chris Athanassopoulos**, Assistant Professor, Engineering, is the 2021 Professor Powell and Larry Moats Extra Five Minutes Faculty Award recipient. The Student Government Association chose Chris for his willingness to take extra time both in the classroom and outside of class to ensure his students succeeded. The student who nominated Chris shared that he always listened and communicated information in a concise, real and helpful way. Chris' efforts to make a lasting impact on his students is demonstrated by his nominee sharing that they planned to leave Harper College with an associate degree and return to the workforce with no plan to utilize their degree. Due to Chris' dedication to see his student succeed, he encouraged the student to complete their Associates in Engineering and create a meaningful plan for their future. As the student wrote, "I have had other instructors who have wanted me to succeed but not to the extent of Mr. A. He is truly the best of the best."
