Donor generosity inspires new scholarships

The Harper College Educational Foundation thanks the donors of these new scholarships for their generosity and for inspiring Harper students to realize their dreams.

Karma Foundation Scholarship: Created by Harper alumna Shipra Rajput, an international student who earned her associate degree from Harper College in 2016 and her bachelor's in biomedical engineering from Washington State University. She is currently a Manufacturing Engineering at Edwards Life Science and created this scholarship to support an international student with financial need.

Kathleen Hartwig Endowed Scholarship: Created by community member and donor Kathleen Hartwig for female students with financial need and a GPA of 2.0.

Mike and Melissa Canning Scholarship and Mike and Melissa Canning Transfer Scholarship: Created by community leaders Melissa (also a Harper College alumna) and Mike Canning to support Harper students who have financial need. The transfer scholarship pays for tuition at the University Center at a Harper College partner school.

Robert and Jennifer Allare Scholarship: Created by adjunct faculty member Robert Allare and his wife, Jennifer, for graduates of Prospect or Hoffman Estates High School, preference to students that played sports in high school and a preference for community service engagement (see more about Robert and Jennifer on page 8).

Schaumburg-Hoffman Lions Club Scholarship: The Schaumburg-Hoffman Lions Club established this scholarship to support a student that lives or works in Hoffman Estates or Schaumburg who has financial need and has demonstrated community service.

The Inspire Scholarship Campaign will expand financial support for Harper College students by creating new opportunities or expanding existing scholarships to assist current and future students. Harper College Educational Foundation gives \$100K to local nonprofits

The Harper College Educational Foundation recently granted \$100,000 to five local nonprofit organizations as part of its new Community Innovation Fund Grant Program.



The program provides one-year grants to nonprofit organizations whose missions support the advancement of equity, diversity and economic mobility for underserved and marginalized communities in Harper's district. The program's goals align with Harper's efforts to reduce the college's equity gaps by 20% by 2024.

"Harper and the Educational Foundation are inspired by the determination and ambition of these organizations, which share the college's mission to better our communities," said Laura Brown, vice president, and chief advancement officer. "The Community Innovation Fund provides a wonderful opportunity to partner with groups seeking to assist under-resourced students, help at-risk single mothers and support victims of domestic violence."

The five organizations that received a Community Innovation Fund Grant include:

- Partners for Our Communities, Palatine
- GiGi's Playhouse, Hoffman Estates
- WINGS, Palatine
- Fellowship Housing Corporation, Hoffman Estates
- Barrington Area Development Council, Barrington/Carpentersville

All five grants are set to significantly impact Harper's district. Kathy Millin, executive director at Partners for Our Communities, which

was awarded the largest grant, spoke about her appreciation of the Community Innovation Fund Grant Program and the difference these funds will make in people's lives.

"I have to tell you, when we first got the news, we cried. Our staff felt this sense of joy," Millin said. "We're seeing such despair and hopelessness out there, which scares me. We're excited to help normalize taking care of your mental health for these young people."

Harper and its foundation announced the grant program last spring. Area organizations were encouraged to apply and detail how they would use the funding for projects, programs, activities and services that focus on uplifting activities with long-lasting impacts and outcomes. Each grant is for one year (July 1, 2022, to June 30, 2023), and recipients will be allowed to apply for a one-year renewal.

Part of the impetus for the Community Innovation Fund Grant Program was MacKenzie Scott's \$18 million transformational gift to Harper in 2021.

"MacKenzie Scott wrote how generosity is generative, and that sharing makes more," said Dr. Avis Proctor, Harper president. "The goal of these grants is to advance work supporting equity, diversity and economic mobility within our community for years to come. Together we can generate transformational and strategic impact for our entire community to thrive."

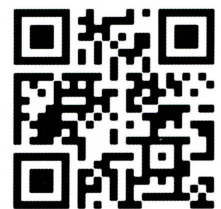
As President of William Rainey Harper College, I am proud of our direction as we ignite multiple paths toward student success and institutional excellence.

Family legacy helps to achieve dreams

The Turpin and Soderholm families have resided in the Harper College district since 1956 and were early community college supporters.

Since its inception, three generations have attended Harper College, and Robin Turpin and Laurie Turpin-Soderholm have been named Distinguished Alumni. Family members have served as Harper faculty, performed in Harper theatre performances and volunteered on numerous Harper College Educational Foundation committees and the Foundation Board.

The family is firmly committed to supporting education as the path to increased life satisfaction and affluence. Robin and Laurie have been instrumental in supporting, championing and funding

individual scholarships, the Promise Scholarship program, and college-sponsored programs. Robin is a Harper Heritage Society member and has left plans for Harper College in her estate plans.

In 2009, they established the endowed Shirley L. and Howard A. Turpin Scholarship for Dreamers, named after their parents. The scholarship is for students who have achieved a 3.0 GPA, have financial need, and most importantly, have a clear vision of how a Harper College education can help fulfill their dreams for the future. Since its inception,

the Shirley L. and Howard A. Turpin Scholarship for Dreamers has supported more than 17 students. Robin and Laurie say meeting the students and seeing their passion and perseverance has inspired them. "We are so excited to see them achieve their dreams," said Laurie.

In honor of the Turpin and Soderholm family's generosity and support, the Harper College Performing Arts Center lobby was dedicated to their families in the spring of 2022 and officially named the Turpin Soderholm Family Performing Arts Center Lobby.

The scholarship's financial support relieved some of her family's financial burden and empowered her to finish her journey toward her associate degree.

Today, Lindy is beginning her bachelor's degree in accounting through Harper's University Center with her sights set on becoming a Certified Public Accountant.

Adjunct faculty and alumni create scholarship to help students explore their passions

Robert and Jennifer Allare's history with Harper College runs deep. Both graduated from high schools in Harper's district. Both took classes at Harper before completing their undergraduate degrees at Illinois State University. Both have remained committed to helping students in our community transform their lives through the power of education.

Today, Jennifer co-owns a nationwide company, and Robert is an adjunct faculty in the Department of History at Harper and president of the Adjunct Faculty Association. Together they made the decision to share the gift of a Harper education. As Jennifer notes, "I think that's our biggest desire: to help some students get back their footing and education out of high school while they try and figure some things out."

The Robert and Jennifer Allare Endowed Scholarship supports graduates of Prospect High School and Hoffman Estates High School who are involved with their community. "Since I teach here, I know it's an opportunity for students to explore," says Robert, "College, in general, is that opportunity to test drive different things and decide where you want to go."

Jennifer, whose experience as a Harper student was taking Spanish classes over the summers, is particularly interested in Harper's approach to placing students on a career pathway. She sees the need for students who are interested in hands-on trades in her work, "I work in the construction industry, and there is a complete shortage of skilled labor...Maybe they can complete their associate degree, become a mechanic, or study nursing. Whatever it is, [students] get on some sort of path and have their home base here."

Robert has seen the toll finances can take on students, sharing that some of his students are working two jobs to make ends meet



while others are working full-time and balancing school. Robert recalls that while in college, he did not face the same pressure to work while attending school.

"Harper was a great location for me. I don't think it's much more complicated than giving someone an opportunity we had back in the day," suggests Robert. Their scholarship will accomplish this for Harper students for generations to come. In establishing an endowment, the Allares have made the commitment to giving Harper students a chance to learn and grow in perpetuity.

Connecting Business
and Community

As part of its Harper@Work program, the Foundation piloted its Corporate Mentorship Program during the Summer of 2022. The program stemmed from conversations with corporate partners who communicated an increased need for programs that promote leadership and corporate responsibility and their difficulties recruiting the diverse, skilled workforce they desire. Out of this challenge, a new idea was born. The opportunity to connect Harper scholarship recipients with Foundation Business Champions was a win-win. These community-minded businesses found ways to strengthen their current and future workforce while preparing hardworking Harper students for their future careers.

During the pilot program, three businesses participated: Clearwater Capital Partners, Motorola Solutions and Vistex. Employees from a variety of backgrounds and job titles volunteered their time to coach Harper students virtually during the summer. Feedback from both students and mentors was positive, and of the 13 original pairings, five pairs requested to continue their connection throughout the fall semester. Following the successful pilot, 10 businesses identified 53 mentors for the 2022-2023 cohort.

Your Community's College

In early October, Harper College celebrated the investiture of Dr. Avis Proctor as the sixth president of Harper College. The pandemic prevented the college from doing so sooner, and the college community was pleased to be able to do so now.

Before arriving at Harper College, Dr. Proctor had 25 years of experience working in multicultural environments as an innovative mathematics educator and academic administrator with a focus on teaching, service and research.

Since her arrival, Dr. Proctor has continued the important work on student success initiatives. During this time, the college was acknowledged by the Aspen Institute as a semi-finalist for the prestigious College Excellence Program, which means that Harper is considered one of the top 25 community colleges in the country. This is the nation's signature recognition for America's community colleges—as President Obama called it, “basically the Oscars for great community colleges.” The Aspen Prize honors colleges with outstanding achievement in five critical areas: teaching and learning, certificate and degree completion, transfer and bachelor's attainment, workforce success, and equity for students of color and students from low-income backgrounds.

In addition, in 2021, Harper received an \$18 million gift, the largest gift in the college's history, from philanthropist, activist and author MacKenzie Scott. It was used to create the Igniting Paths to Success scholarships which awarded full tuition, fees and books to 1,000 students, helping to address an urgent need for many in our community struggling to access and prioritize higher education due to the challenges and uncertainties of the COVID-19 pandemic. Funding from this significant gift was also used to provide one-year grants to nonprofit organizations (see page 4). The program's goals align with Harper's efforts to reduce the college's equity gaps by 20% by 2024.

Events and activities leading up to the formal investiture ceremony were attended by students, community partners, employees and others who contribute to the success of the college.

The formal investiture ceremony and swearing-in of the new president took place on October 6, 2022, and included delegates from other colleges and universities, as well as faculty, staff and community members.

What is an investiture?

The investiture of a new president is a ceremony of dignity with many academic traditions and protocols. Originating in English universities, the investiture ceremony is among the oldest of traditions in academia. The word investiture comes from the Latin phrase for “dress in robe.” In academic circles, the term has come to mean one who will literally don the university's insignia and regalia.

2022 HOPE Giving Circle Scholarship Reception

HOPE awards \$10,000 scholarships to four students

The Harper College Educational Foundation's HOPE Giving Circle brings together influential women with a common goal of supporting women to pursue higher education and reach their full potential through financial support, ongoing mentoring and leadership development.

This year, the group awarded \$10,000 scholarships to Harper students Emily Alvia, Taiah Guess, Lydia Schultz and Genevieve Wulf, who were honored at a recent awards reception.

"We are a strong community of women supporting the next generation of female leaders," said Kathy Gilmer, chair of the HOPE Giving Circle Executive Committee and a founding HOPE member. "Year after year, we have the privilege of seeing first-hand the difference the HOPE Scholarship makes in the lives of these young women."

The HOPE Scholarship is awarded to female students who are completing their final year at Harper and are planning to transfer to a four-year institution. Applicants must have a 3.0 minimum GPA and demonstrate community service or involvement.

Since its inception seven years ago, the HOPE Giving Circle has awarded \$10,000 scholarships to 22 Harper students. In total, 120 donors have contributed more than \$270,000 in support of future female leaders.

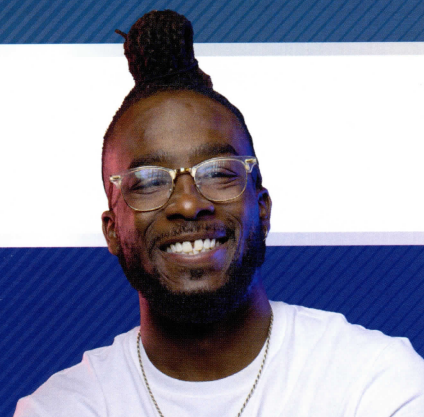

Harper Alum's passion for social work, social justice ignited at Harper College

Years before Dr. Justin Harty (A.A. '08) became a trailblazer in the field of Social Work and an assistant professor in the School of Social Work at Arizona State University; he was a high school graduate questioning if college was the right path for him. He worked at Menards after high school before enrolling at Harper part-time.

He recalls not knowing what direction his life should take. However, it was in Professor Sean Noonan's sociology class that something finally clicked for him.

"I just didn't know what my future was," said Dr. Harty. "I first enrolled in fire science, but things quickly changed when I took a handful of sociology and philosophy courses. I knew that was the path for me."

He credits Professor Noonan, who passed away earlier this year, and Harper College faculty member John Garcia with igniting his passion for sociology and philosophy.

"Sean made an impact on me. He was the first one to expose me to activism and really encouraging dialogue around uncomfortable topics of conversation," said Dr. Harty. "My time at Harper, at points, was harder than any education that came after that."

After seven years of part-time enrollment, he persevered to achieve his Associate of Arts in 2008. Dr. Harty earned his bachelor's

degree from UIUC in 2011, double majoring in sociology and philosophy, and then earned a Master of Social Work from the University of Illinois at Chicago.

Following the completion of his master's degree, Dr. Harty worked as a foster care caseworker for DCFS in Chicago. In his work, he noticed the lack of support for the many young black fathers currently in and aging out of the foster care system.

He realized that research into this area was vital. With a goal of contributing to research and making change in this area, he applied to several top doctoral programs including the University of Michigan, Washington University and the University of Chicago. He was accepted into them all.

Justin Harty officially became Dr. Harty when he earned his Doctorate in Social Work in May 2022 from U of C. He successfully defended his dissertation "Fatherhood in foster care: Black fathers aging out of foster care in Illinois." In his acknowledgments section of his dissertation, he thanked the Harper College professors who sparked his passion: Sean Noonan and John Garcia.

"I love social work because it helps people live in the world as we want it to be," said Dr. Harty.

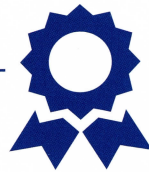

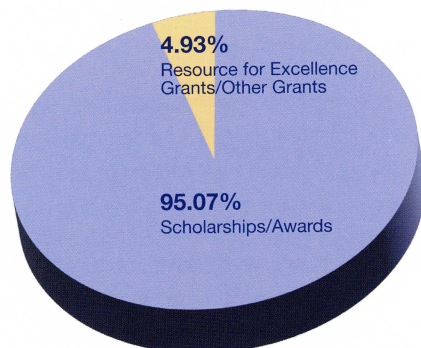

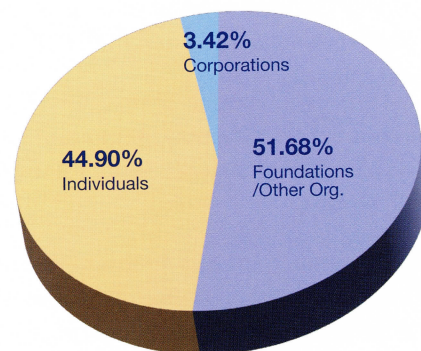
