

# Shida family shows gratitude for the community with Harper scholarship

When Mina Fey reminisces about being raised in the northwest suburbs of Chicago, she thinks about a nice place to grow up with a supportive community. She reflects upon how Harper College was a major resource for this community.

"We were fortunate to have a nice childhood, thanks to my parents, but also to the community," Fey said. "We value what Harper does. Looking back, it was always there for us and the community where we grew up."

Fey's parents, Mitsuzo and Kyoko Shida, raised three children - Mina, Miho and Yuzo - in North Barrington. Mitsuzo and Kyoko had first settled in Brooklyn after emigrating from Japan in the late 1950s so Mitsuzo could earn his Ph.D. in polymer science.

In the '60s, plastics were a frontier in consumer science. Mitsuzo's work in this field moved the family to the Chicago area. As a scientist, he created polymer applications for packaging we now take for granted, including adhesives for plastic films in various consumer products. He amassed more than 50 patents.

Fey says she didn't fully appreciate her father's innovations growing up -"He was just a good, strict, dad." After Mitsuzo passed away a few years ago, Kyoko and her children sought to give back to the community that had given them so much. Harper was an obvious choice.


Although none of the Shida children attended Harper full-time, Fey took a course during a summer home from the University of Illinois at Urbana-Champaign and her sister Miho did art therapy volunteer work with disabled adults at the college.

"It's pretty amazing that one school can satisfy so many different needs for so many different people," said Fey, referencing how many educational avenues and resources are available at Harper. "We thought, 'What better way to give back than to give to a place that gives back to the community?"

That's why Kyoko and her children created the Shida Family Endowed Scholarship in 2021 with the goal of helping students with great financial need. In honor of the family's generosity and Mitsuzo's scientific contributions, Harper will name Building Z the Shida Family Science Building. The family came to campus last fall, and Fey said they were inspired by Harper's passionate faculty and staff as well as the great facilities.

The Shida Family scholarship also was designed to encourage applicants who aren't eligible for federal aid due to citizenship status, a detail important to Miho because of her nonprofit work with Latinx youth. In addition, the scholarship gives preference to those who demonstrate community involvement.

"Education and effort are core values that have been instilled in our family," Fey said. "These students are facing such adversity in their lives, yet they want to rise above that adversity to try to better themselves. We think that deserves to be recognized."

# Harper alum receives transfer scholarship to University Center at Harper College

Krystle Magsino has been involved with Harper College for nearly 15 years.



Krystle Magsino's path to Harper has taken many twists and turns. This year, thanks to her determination and support from a generous donor, Krystle will achieve a dream that she once thought was unreachable. She will graduate summa cum laude from Northern Illinois University after enrolling at the University Center at Harper College.

After graduating from Schaumburg High School and spending one semester at the University of Illinois Chicago, Krystle enrolled at Harper College as a Distinguished Scholar. She describes her experience in attending Harper as, "That cheesy feeling people describe when they visit a college, and they know they are just meant to be there and go there - I felt that here. It was such a shock to me that Harper felt so right." After earning her associate degree from Harper, Krystle began working in the car industry and was promoted to management in just a few short years. For nearly 10 years, she worked in the industry and was grateful for her career but knew that she wanted more. She wanted to go back to school and earn her bachelor's degree in psychology.

Krystle enrolled at Northern Illinois University through the University Center at Harper College in the spring of 2020. Her first semester back in school became a lesson in navigating school and a pandemic. In addition, she was furloughed from her job during the pandemic, found a job at another dealership, and furloughed again. At that time, she decided she needed to invest in herself and enrolled full-time in school and found a part-time job at a local Starbucks. While Krystle felt nervous about the financial risks she was taking by decreasing her income, she knew she needed to focus on her studies to fulfill her goal.

In the fall of 2021, Krystle received the Beaubien Family Transfer Scholarship, which supported her tuition at the University Center. She says of receiving the scholarship, "Because of the Beaubien Scholarship, the seemingly unreachable dream I have had my entire life is now at an arm's reach. If it weren't for this scholarship, I might be working at a car dealership just trying to make ends meet while taking a class or two for the next several years. Instead, I will graduate this spring."

# Second chance leads to steadfast support of Harper students

Harper College helped Randal Allen turn his life around. The scientist, professor and donor is dedicated to helping others gain new opportunities via scholarships.

Randal Allen's resume includes bachelor's and master's degrees from the University of Illinois at Urbana-Champaign, a near-doctorate from Stanford University (the program included everything he needed for a Ph.D. minus a dissertation) and a traditional doctorate from the University of Central Florida.

But the school that started it all, the one Allen selected to be the recipient of his scholarship donations, is Harper College.

"'I got this second chance,' he said. 'If I'm going to invest my money, we invest it with Harper, to give other people that second chance if they need it.""

In high school, Allen said, he wasn't a great student. He graduated early - not because he did exceptionally well in his classes but because he figured out a way to be done with school guicker. He took classes like business math, business English, business law and marketing. "It was a business focus, but it was a program for people that weren't cut out to go to college," he said.

After graduation, Allen got a job in shipping and receiving for about a year. "And then I got into trouble, and the trouble is what changed my life," he said. Allen was arrested, and he spent one night in jail. After, he figured that if he went to college, he might be able to staunch his parents' disappointment.

That business focus in high school served Allen well in the long run - how many people graduate from high school understanding the fundamentals of a mortgage? When he enrolled at Harper, he started with basic courses.

Some resonated, some didn't, leaving him to focus on math and English in his first semester. He got an A in algebra and figured, "Let me go through the math sequence, then. Let me take trigonometry and college algebra." He again got A's in his math classes, which lead to analytic geometry, calculus I and II, and ordinary differential equations.

Along the way, he met Dr. William Schooley, a calculus professor - currently professor emeritus - who saw Allen's potential and helped him find different scholarships. He offered to write letters of recommendation, which he contributed throughout Allen's academic career.

Allen's continued success in Harper's math classes led an advisor to suggest that Allen explore the sciences. He took three semesters of chemistry and three semesters of physics, earning all A's. He received his associate degree in pre-engineering after three years at Harper and took one more year to finish the classes needed to transfer to U of I as a junior.

Today, Allen is chief scientist at Lone Star Analysis, Inc., in Orlando, Florida. He has a patent pending on an invention related to artificial intelligence - he's created a speedier Al process that uses less data and has fewer computer requirements than traditional Al.

He teaches at one alma mater, UCF, but he chooses to help students financially at Harper through the Mathematics and Science Endowment scholarship. His other alma maters have reached out, but Harper helped him when he needed it most.

"Harper said, 'I know you got a 17 on the ACT. You never took the SAT. Come on in.' I got this second chance," he said. "If I'm going to invest my money, we invest it with Harper, to give other people that second chance if they need it."

# Business student receives inaugural Educational Foundation Board Designated Endowed Scholarship

"Receiving this scholarship means not stressing about where my next gas money will come from; not picking up that extra shift at work; not stressing about where to get the money to pay off my laptop bill," said Nour Hussein Abdallah, an inaugural recipient of the Educational Foundation Board Designated Endowed Scholarship. Nour is a first-year Harper student studying business and an Elk Grove High School graduate. She shared, "Thank you so

much for giving me the relief of knowing that my financial situation will never be a problem when trying to pursue my dream career path."

The Educational Foundation Board

Designated Endowed Scholarship was
created more than a year ago to help
students with financial need who are
enrolled in nine or more credit hours. The
Educational Foundation Board saw a need

to increase their support to scholarships that help students with their tuition and fees. Endowing the scholarship fund creates a lasting legacy because the scholarship will be awarded to students in perpetuity. The criteria was intentionally set for students with financial need to help those who need additional support with their tuition and fees. The scholarship also requires students to enroll in nine hours to help them finish their degree faster.

# Scholarship donor is a 'cheerleader for Harper'

Harper College helped Ann Kimberly forge a new educational path. She's now started three scholarships to help students with theirs.

When Ann Kimberly enrolled for her first class at Harper College, she already had a bachelor's degree in special education from the University of Wisconsin. Her goal wasn't to kick-start her education; it was to forge a new path.

She spent some time working in special education but stopped to raise her two sons. When her boys were young, she decided she wanted to be a writer, so she enrolled in a few Harper journalism classes. One day, she found a job opening in Institutional Communications - which is now Marketing Services.

"I went in there, and I was scared to death," said Kimberly, of Lake Barrington. "I had been home for 12 years raising a family, and I was in a field that I had never done anything with. But Harper gave me the confidence through the journalism program, and they gave me the confidence by hiring me."

Between the Harper classes and the work experience - followed by her receiving her master's degree at DePaul University - Kimberly was set up for anything she wanted to do in her career.

Because of her love of education and her desire to help others, Kimberly has established three scholarships at Harper College, each geared toward helping different groups of students and prioritizing Kimberly's own passions:

- Students who receive the WorldView Study Abroad Scholarship learn about a developing country, then travel to that country for two weeks. Kimberly is an avid traveler – she estimates that she's visited more than 100 countries - and she knows that community college students might not typically get a chance to study abroad.
- The Access for All Scholarship is for students who don't qualify for federal financial aid.
- The third scholarship Kimberly funds is one that marries two schools she loves: It covers a student's last year at Harper, plus an additional two years at its University Center, where students can finish their bachelor's degrees at one of four



universities by taking classes onsite at Harper. Kimberly's scholarship is for students studying communications, marketing or business at DePaul University.

"I'm a cheerleader for Harper," she said. "It's a huge asset to our community. It's a diamond. I value education so much. If I can help somebody get an education, boom, I want to make it happen."

# Clearwater Capital Partners establishes endowed scholarship

# Promise Update

This spring, Harper College will celebrate its second class of Promise graduates. Since the program's inception in 2015, more than 40,000 students in Harper's sender high schools have been involved in the program. The Promise Program asks students in high school to work hard in school, show up to class and give back to their community. In return, they can earn up to two years tuition at Harper College. More than \$20 million has been raised for the program between private investments and community support.

# Donor generosity inspires new scholarships

scholarship with Harper College and will support working female students involved in community activities and have financial need.

Kimberly Family Achieving Dreams Scholarship: Ann
Kimberly created this scholarship to support marketing or business
students during their final year at Harper College and for two years

while attending DePaul University at the University Center at Harper College. (see page 11 for more about Ann).

League of Women Voters - Arlington Heights, Mount
Prospect and Buffalo Grove Scholarship: Created to support
adult female students who live in high school district 214 and are
from an underserved population. Created by the League of Women
Voters - Arlington Heights, Mount Prospect and Buffalo Grove.

**STEM Achievement Scholarship:** Dave Braunschweig and Cindy Miller have a long history with Harper as employees and alumni. They have established a scholarship to support STEM students (preferred focus on CIS students) who are 22 years of age or older, involved in community service and have financial need.

**Wintrust Scholarship:** Wintrust has been a long-time supporter of Harper College students through philanthropic support and volunteer engagement. Wintrust created this endowed scholarship to support students who have financial need.

# Harper College Celebrates Harper Heart Day

On February 23 and 24, the Harper community came together to celebrate Harper HEART Day. In 2020, Harper College pivoted from engaging in #GivingTuesday, the national day of philanthropy celebrated the Tuesday after Thanksgiving. The Harper College Educational Foundation stepped out and established Harper HEART Day, our very own day of giving in which our community Helps Everyone Access Resources Together. During these 36 hours of giving and engagement, Harper alumni, faculty and staff, retirees, students and friends joined together to raise funds for Harper students and to celebrate the inspirational power of education.

Activities throughout campus (both virtually and in-person) celebrated our vibrant community and engaged donors in supporting Harper students.

# **Pepper Family Dedication**

A focal point of Harper College's campus for students to study and gather will now be known as the Pepper Family Foundation Academic Support Center.

Harper held a ceremony on November 19 to formally dedicate the space in recognition of the Pepper family of Barrington for their contributions to the Promise Scholarship Program exceeding \$400,000.

"The Peppers have been instrumental in supporting, championing and funding the Promise Scholarship Program and foundation – and college-sponsored programs," said Dr. Avis Proctor, president of Harper College.

Richard Pepper, who passed away last year, and his wife Roxelyn have been dedicated supporters of Harper. Members of the family have also been active in serving on various fundraising and scholarship committees: Scot Pepper is a member of the Harper College Educational Foundation's board of directors, while Lynda Bollman has supported the HOPE Giving Circle since its inception.

"We couldn't be more excited and proud to have our name on this building," said Scot Pepper, who spoke on behalf of several relatives in attendance. "Supporting Harper is a passion in our family."

The Academic Support Center, located on the first floor of the David K. Hill Family Library, contains seven centers: the Tutoring Center, Writing Center, Success Services, Anatomy Room, Developmental Math Center, Supplemental Instruction and Community Tutoring Center.

Ellen Fisher, the Academic Support Center manager, said the centers collectively provide support in more than 100 different subjects. Both online and in-person services are offered. During the 2019-2020 academic year, the centers connected with 18,000 students.

Ellen said the space is integral to student success, pointing to data from Harper's Institutional Research department.

"Again and again, we see that students who work with tutors succeed and persist at higher rates," she said.

In his remarks, Scot Pepper also pointed out a special connection between his family and the library: Pepper Construction served as construction manager for the building, which opened in 2018.

# A scholarship for the C students

Harper College's supporters come from all sorts of backgrounds. There are the college's graduates and its employees. There are those students who take a class, or three, to improve their skills or explore a new career path.

And there are those like Gerald Fitzgerald Jr., who's been familiar with Harper since its 1967 inception when the college held evening classes at Elk Grove High School. He's lived within two miles of Harper for most of his life, but his first real knowledge of the college came when he decided to mentor a Harper student.

EB211 is a scholarship program to help hardworking students from underrepresented communities. As a mentor in the program, Fitzgerald met Guillermo "Memo" Quillo, who went through Harper's engineering program and earned his associate degree, then transferred to the University of Illinois at Urbana-Champaign for his bachelor's degree in aeronautical engineering.


After seeing how much Harper helped Quillo, as well as the quality of its academic programs, Fitzgerald learned more about the college's importance to the community and local employers. He decided he wanted to help other Harper students.

"It is a great community resource that, in my opinion, is only going to get greater," Fitzgerald said.

The Fitzgerald Family Endowed Scholarship is for students who are first-generation college students, immigrants or children of a firstgeneration immigrant, have a disability or are from an underserved community. They must also have a financial need and demonstrate persistence, and the scholarship gives preference to C students with these traits over A students who do.

That's because Fitzgerald wants to nurture students' potential.

"Oftentimes, in any educational program, the top students get a lot of attention, and the students in the bottom 10 percent don't get a lot of attention," he said. "But a lot of the C students who have a lot of potential to do great things for their community sometimes get lost in the shuffle. And so I hope the scholarship goes to a C student with a lot of drive and desire."





# Fremd graduate and eagle scout receives **David K. Hill Memorial Scholarship**

The David K. Hill Memorial Scholarship was created in memory of David K. Hill by his family and friends. David was a member of the Harper College Board of Trustees, a community leader, a prominent national businessman and philanthropist.

The scholarship is open to students from science programs who exhibit exemplary achievement in academics and community service.

This year's recipient is Justin Glab, a first-generation college student in the Harper Honors Program and studying biochemistry. He is an Eagle Scout and was on the varsity water polo and swim team at Fremd High School.

establish myself in this world, give back to my family and those that I love around me. I am solely responsible for paying off any debt I receive. This scholarship will allow me to delay taking out loans as long as possible and to allow me to work as little as possible during my college studies which will help ensure my dedication to schooling."
