STARS OF THE PAST...STARS OF THE FUTURE The President's Ball 2012

It also, she says, empowered her to study education, which revealed her full potential.

Galvan shared her story at the 45th Anniversary President's Ball on Saturday, September 22, urging the 300 supporters in attendance to fund scholarships and, in turn, more success stories.

"If someone is able to provide a scholarship, you can be sure that student is going to impact the lives of many people," said Galvan, a recipient of the Motorola Solutions Foundation Award for Excellence and a member of the Harper College Speech Team. "It's partially a building of a community: understanding that your involvement touches someone else, and that they will touch others."

By the night's end, the dinner-and-dancing gala had raised nearly \$300,000 for scholarships and programs—a total that included sponsorships and donations, ticket sales, silent auction proceeds and income from a live appeal for scholarship funding, which saw guests enthusiastically support awards to cover everything from a single credit hour to a year of part-time or full-time tuition.

Celebrating Success: 100 INFLUENTIAL WOMEN BREAKFAST



Catherine Clarke, Women's Program Graduate

Catherine Clarke had no firm plan when she walked in the door of the Rita and John Canning Women's Program at Harper College. She just knew something had to change.

In the end, the program "completely changed the trajectory of my life," said Clarke, a mother of four who transferred to Elmhurst College—

where she carries a perfect 4.0 GPA—after completing her Harper education. She came to campus as a divorced former homemaker who'd left her marriage because of domestic violence. She left with a goal of a master's in counseling.

Her journey took center stage at the 100 Influential Women Breakfast, a fundraiser for the Women's Program held in the Wojcik Conference Center on Friday, September 7.

"My circumstances do not define me, nor do they confine me," she told attendees during her comments. "I've learned I can do more, and I can be more than I ever thought possible."

Clarke's speech preceded a keynote from Anne Pramaggiore, ComEd's first female CEO.

Pramaggiore, a former film major who took an untraditional route to her current job, knows well the power of determination, and the role that personal advocates can play in

achieving success. In her speech, she urged women to color outside the lines and, more broadly, forget what they learned in kindergarten: big girls do cry, and sometimes you have to interrupt to be heard. She also applauded the Women's Program, and urged attendees to answer the call to empower others.

The breakfast, sponsored by Rita Canning and Linda Lang, raised nearly \$46,000 for the Women's Program, the only remaining program of its kind in the state. The program provides educational support and resources and the opportunity for a fresh start to hundreds of single parents, former homemakers and others—more than half of whom are domestic violence victims—every year. Enrollment climbed amid the recession.

"Our participants see us as the hope and the help that they need to get through whatever they're going through. In many cases, they depend on us to take their lives in a new direction," Women's Program Director Kathleen Canfield said. "We need to continue to be there for them. Individual contributions make a real difference as we seek to continue our program's support."

A state grant that helped fund the program was eliminated in 2008, and the 100 Influential Women initiative was launched a year later, with an initial goal of raising \$100,000 through the contributions of at least 100 donors.

"I can't think of a better way to support the community," said Rita Canning, a donor and the program's namesake who also sits on Harper's Board of Trustees and helped plan the event. ■

As the Chief Development Officer for the Mayo Clinic Health System in Eau Claire, Wisconsin, Dr. Mary Knight oversaw a \$12.5 million campaign for a hospital expansion, an \$8 million campaign to build a new emergency department and a \$2 million campaign to build a corporate child development center.

She's now bringing her talents—and her ability to drive change—to Harper College.

Dr. Knight was appointed in August by the Harper College Board of Trustees to serve as the new chief advancement officer and the executive director of the Harper College Educational Foundation.

“Given state and federal cuts in financial aid programs, the Foundation is playing a critical role in ensuring finances are not a barrier to student success at Harper,” said Harper College President Dr. Ken Ender.

“Dr. Knight not only has a strong record of successful fundraising, but she has a passion for higher education and its role of transforming lives and building community partnerships.”

24th Annual Harper Educational Foundation Golf Open 2012



Thank you to our golfers who helped make this year's event a success.

Nearly 100 golfers teed off in the name of student success at the Harper College Educational Foundation's annual Golf Open, held on Monday, June 11, at the Inverness Golf Club.

The event netted nearly \$57,000 for the Foundation's Resource for Excellence Fund, drawing on robust corporate sponsorships, golfer registrations and proceeds from a raffle and silent auction to fuel funding for student scholarships and programming across the campus.

The Open featured 18 holes of golf as well as a brunch, cocktail reception and awards dinner. Harper alumnus Jim Tufts, now a chemistry student at the Illinois Institute of Technology, served as the guest speaker, telling attendees how Harper's unique undergraduate chemistry research program—which has received Resource for Excellence funding—changed his life.

Tufts, who spent two years working on graduate-level research involving hydrogen storage and polymers, said the work gave him purpose and instilled confidence he wouldn't otherwise have.

In addition to the chemistry research program, proceeds from Educational Foundation golf outings have launched or supported programs for the unemployed, computer courses for participants of the Rita and John Canning Women's Program at Harper College and bridge programs that ease the high school-to-college transition and boost students' chances of success on campus.

The 2012 planning committee was co-chaired by Educational Foundation Board Member Mark Cleary of Northrop Grumman and former Board Member George Powers of Schneider Electric.

Next year's Open is set for Monday, June 10, at Inverness Golf Club. ■

Q&A with the new Foundation Board President: **THOMAS G. WISCHHUSEN**



WHERE DID YOU GROW UP AND GO TO COLLEGE?

I grew up in Ridgewood, New Jersey, a suburb of New York City, but moved to Palatine in 1974 when I was 16 years old. I attended and graduated from Palatine High School. Given that I have lived in the Midwest since 1974 and graduated from both high school (1976) and college (University of Illinois-Urbana/Champaign-1980), I consider myself a “Midwesterner.”

HOW DID YOUR CHILDHOOD INFLUENCE YOUR DESIRE TO HELP YOUNG PEOPLE?

I come from a family of caring professionals with my mother, sisters and aunts all being either teachers or nurses. Although my father was an industrial engineer, he served in many volunteer organizations, as well as the leader of our local Lutheran church which also contributed to the family culture of serving the community. This was nurtured within me as a youngster by my participation in Boy Scouts as well as a number of volunteer opportunities including spending every Saturday morning in the ER of the local hospital for a couple of years.

WHAT DREW YOU TO THE HARPER COLLEGE EDUCATIONAL FOUNDATION?

My employer, Northern Trust, has contributed to the Foundation, as well as having someone serve on the Board, for many years. Given this, over the years I have had the opportunity to learn more about the Foundation and the people who were involved, so when there was an opening on the board four years ago, I was excited to have been invited to join. In addition, as a Palatine resident for 38 years, I have had numerous opportunities to become familiar with the College and all it provides. My first exposure to Harper was when I attended two summer school classes during my college studies. After college, I attended numerous continuing education classes and, finally, I try to attend as many cultural events as possible, with my favorite being the theater and music performances.

OVER YOUR YEARS ON THE BOARD, WHAT ARE SOME OF YOUR FAVORITE STUDENT SCHOLAR STORIES THAT YOU HAVE ENCOUNTERED?

I would say that Elisa Galvan's, the winner of the 2012 Motorola Solutions Foundation Award for Excellence, comments at this year's President's Ball was particularly inspiring. She articulated how scholarships can make such a profound impact on the recipient and positively change lives forever. I also have enjoyed hearing the stories of our Distinguished Alumni and how Harper has made such an impact on their lives.

IN YOUR NEW ROLE, WHAT ARE YOUR MAJOR GOALS?

Although I have numerous goals, the three I consider most important are: 1) Increase the amount of contributions to the Foundation to allow us to award additional scholarships and fund programs at the College. This would come about by: 2) Raising the awareness of Harper in general, and the Foundation in particular, and finally this would be accomplished by, 3) broadening the number of donors we are blessed to have.

HOW HAS YOUR CAREER AT NORTHERN TRUST PREPARED YOU TO LEAD THE BOARD?

Northern Trust has always been characterized by the highest level of honesty and character which is what I will bring to the Foundation. For a Foundation to grow and thrive, these attributes are absolutely critical for all of our board members and staff to possess if we expect people who have worked hard for their money to donate it to us for safekeeping and proper stewardship for the enrichment of our students. In addition to this, I believe the skills I have honed over my 27 years at Northern Trust in regards to leading successfully growing business units while doing so in a conservative fashion, will serve the Foundation well.

WILL THERE BE ANY BOARD OPENINGS FOR THOSE INTERESTED IN IMPROVING THE LIVES OF HARPER STUDENTS?

Yes, through natural attrition, I expect there to be openings on the Foundation Board. We will be looking for people with the ability to help us grow and share the message of Harper with the community. In addition to the Board, we regularly have openings on our various committees which is an ideal way for new people to get to know us and determine how their skills can best be used. ■


