Prior to opening night of the Harper College Theatre performance of *Evita*, the Educational Foundation hosted a reception for special guests.

Victoria Claus, a Harper College student and recipient of the Carol A. Zack Memorial Fine Arts Scholarship, shared the importance of scholarships and the need for financial support.

Following is Victoria's speech:

Hello, my name is Victoria Claus. I am a student, a mother, an aspiring artist and a scholarship recipient. Here at Harper College I have been given the opportunity to learn from some truly brilliant minds. I have been very fortunate to have access to one of the best art studios in the state.

"I am fortunate to receive this support. Without it I would not be able to go to school. With the down turn in the economy my family was impacted. My father lost his job and I was faced with the reality that I could not afford to go to school. We did have money saved for my college fund, but since I was the first of four to hopefully be sent to college and we didn't know how long my dad would be out of work, we took no penny for granted. My dad eventually got a third-shift job 25 miles away from home. The paycheck he received from this job was significantly less than his previous job, which he had for more than 30 years. You could really feel a different atmosphere in our family. I applied for scholarships to see if I was able to receive any aid to pay for college. When we got the letter in the mail regarding the Northrop Grumman scholarship, I don't think words could have described how fortunate and thankful we were.

The Northrop Grumman Engineering Endowed Scholarship has allowed me to follow my dreams of one day becoming an engineer. My desire is to finish my two years at Harper then transfer to a four year college for engineering."

Brian then shared his belief in life and the opportunities he has received:

# High ‘Steaks’ Bet Pays Off for Harper Students

Harper College President Dr. Kenneth Ender served up steaks and ate some crow at a local restaurant recently —the result of a high-stakes bet that guaranteed a new scholarship for students in the Harper College Hospitality Management program.

Dr. Ender worked the dinner shift as a professional waiter at Chicago Prime Steakhouse in Schaumburg on April 15, with his gratuities, and a host of additional donations, going toward the new scholarship fund.

“I can’t say the service was flawless, but I can say I worked hard on behalf of our students, and I’m thrilled with the results,” said Dr. Ender, who shadowed several of Chicago Prime’s top servers during the night. “We served a lot of Harper College friends, who gave generously to help us get a great new scholarship off the ground.”

His fundraising, waiting-tables stint raised nearly \$5,700 for the new Chicago Prime Steakhouse Culinary and Hospitality Scholarship. Chicago Prime owner Andy-John Kalkounos donated an additional \$3,000.

Dr. Ender, who received his bachelor’s degree and Ph.D. from Virginia Commonwealth University, made the deal with Chicago Prime owner Andy-John Kalkounos, a Harper and Butler University alumnus, after the two realized their alma maters would meet in the Final Four of the NCAA Division I basketball tournament.

A scholarship was promised either way, but Butler’s victory meant Dr. Ender had to work for it, donning a crisp white Chicago Prime waiter’s jacket, taking drink orders and serving diners to encourage donations.

“This was a fantastic bet: Harper students were going to be winners either way,” Dr. Ender said. “My VCU Rams might have lost, but it was a victory for my Harper Hawks, and that’s what’s important.”

Dr. Ender served up steak, appetizers and a variety of sides to approximately 100 Harper supporters over his six-hour shift. The diners—and the servers—gave his overall enthusiastic service a collective thumbs up.

“I knew Dr. Ender would do a great job, and I knew people would show up to see him do it,” Kalkounos said. “It was a fun opportunity—you had the president wait on you, and you helped students at the same time. He’s not afraid to get his hands dirty for the sake of the students, and I’m glad I was a part of making this happen.”

Kalkounos earned his bachelor’s degree at Butler before completing his real estate broker’s license at Harper, where he has acted in Harper Theatre Ensemble productions and now serves on the

Educational Foundation’s Directors Circle Committee, raising money for scholarships and educational programs. He became managing partner at the independently owned Chicago Prime in 2000, and was named a Harper Distinguished Alumnus in 2010. Those roles, he said, made a Culinary and Hospitality scholarship the perfect payoff for the bet.

The Final Four game at the heart of his friendly wager with Dr. Ender was an unexpectedly rare matchup between two teams—No. 8 seed Butler and No. 11 seed VCU—that were never predicted to make it so far. That Cinderella side story, Dr. Ender said, offered a universal lesson on the value of determination and persistence.

“In the end, it’s about believing in yourself and your potential,” Dr. Ender said. “That’s what our Harper College faculty and instructors teach students every day, and that’s why I was happy to make this bet with Andy-John. We’re always committed to student success, and this was a fun way to continue to work toward that goal.”

# 2010 Tax Laws: Effects on Charitable Giving

Since its creation, the federal tax code has provided incentives to promote charitable giving by citizens and corporations. This favorable treatment has been valuable to non-profit organizations and foundations with a charitable purpose. In 1797, wealth transfer taxes were also incorporated into the tax code and have been modified repeatedly over the last three decades, providing further incentive for charitable consideration through wills and estate plans. Several tax law changes at the end of 2010, modified the system once again.

While tax benefits may not be your primary motivation for supporting charitable causes, proper planning with your professional advisors can significantly impact the benefit you provide to your heirs and the charitable organizations you wish to support. This is an excellent time to consult your advisors about the need to make adjustments to your lifetime and estate gifting plans.

Following is a list of changes to discuss with your advisors:

- **IRA Rollover Gifts**

The IRA gift provision has been extended to the end of 2011 for those over 70 ½ to make tax-favored gifts to charity directly from a traditional or Roth IRA.

- **Traditional Gifts Fully Deductible**

Whether outright or to fund charitable trusts, gift annuities or other planned gifts, the reduction rule that would require higher income taxpayers to reduce their itemized deductions (scheduled to be reinstated in 2011) has been delayed until January 1, 2013.

- **Estate Tax Changes**

The federal exemption amount that a person can leave to non-charitable heirs was increased to \$5 million per person (or \$10 million for a married couple). However, note that the State of Illinois has reinstated its own estate tax with

an exception of only \$2 million. If you live in, or own property in, the State of Illinois and have an estate estimated to be close to or more than \$2 million, this is an item to be reviewed by your advisors.

- **Annual Gift Tax Exclusion**

The amount that can be given as a gift by a taxpayer in any one year to any number of people free from any federal gift tax consequences is \$13,000 for 2011.

- **Reunification of Gift and Estate Tax**

Since 2002, the federal gift and estate tax changes have been 'decoupled.' This meant that the \$1 million exemption for amounts one could gift to heirs during lifetime has been significantly less than the amount that could be left at death (up to \$3.5 million in 2009). Under the new law, the two systems are brought back into alignment and it is possible to give up to \$5 million during lifetime or at death. (Note that the annual gift tax applies to gifts given to an individual in excess of \$13,000 in a single year.) ■

# Former Students Give Back to Harper

Former Harper College graduates Jake and Jordan Sadoff recognize the struggles that today's students are having funding their college education.

The Sadoff brothers took two different educational paths—one worked and funded his way through college; the other enlisted in the National Guard. Both were successful in their academic pursuits.

Today twin brothers Jordan and Jake Sadoff are successful business owners. In the 1990s the Sadoff's opened JS Enterprises, which specialized in the trading of collectible toys. They worked diligently to build the business from the ground up. However, in 2008, as the collectible toy industry faded with the economy, they converted their business into Schaumburg-based Midwest Gold Buyers. Currently, with more than 40 stores, they are the largest gold buyers in the Chicago area.

However, the Sadoff's success does not stop with their business achievements. This year they choose to make a difference in the lives of Harper students by establishing the **Jacob and Jordan Sadoff Scholarship** to support Harper College Speech Team participants. The first award will be made in fall 2011.

These former Harper College graduates continually define their commitment to education through their thoughtful generosity.

# Summary of Resource for Excellent Grant Awardees

The Resource for Excellence Campaign is one of the sources of support for Harper student scholarships. It also provides the funds for the Resource for Excellence grant program.

The grantees below represent two of the six projects/programs awarded for 2011-2012:

**Book Bag Literacy Project** under the direction of Kathy Dowd, Irena Bakalus and Tara Mathien  
**One Book One Campus** under the direction of Njambi Kamoche and Michele Ukleja

**The Book Bag Literacy Project** is a collaboration between the Northeast Center Reading Room, the Future Educators Club, Child Learning Center staff and Academic Enrichment and Language Studies faculty.

As a way of promoting stronger literacy skills in the English as a Second Language (ESL) community that Harper serves, students of the Future Educators Club will create activity packs for books that will be circulated to ESL families that utilize the Child Learning Center and the Northeast Center Reading Room. A book bag pack will consist of one Pre-K book in English and one book in the family’s first language—Polish, French, Spanish, or Gujarati. CD recordings of the books in English, and in the respective language, will also be available for circulation.

An additional aspect of this project will involve book packets for children in grades 3-8. The packets will consist of one book, one professionally read CD in English, a professionally developed discussion guide and developmentally appropriate activities. Further, parents of students in grades 3-8 will have the opportunity to borrow Kindle Audio Books to promote self-guided reading activities to further develop English language skills.

**The One Book One Campus** initiative is a collaborative effort to encourage students, faculty and staff to read one book and participate in a variety of academic, cultural and social activities related to the book during the 2011-2012 academic year.

A planning committee representing various departments of the College will review potential titles and make a selection for the campus to read. The books will enable the exploration of diverse perspectives and have multi-disciplinary themes and relevance.

The goals of this new initiative are to encourage reading, strengthen connections in the Harper community and increase student use of the campus library and other academic resources. ■
