Harper College – Associates in Arts Degree in Business Administration to Robert Morris University – Bachelor of Business Administration <u>Degree in Management</u>

This Articulation Agreement is entered into by Robert Morris University and Harper College in order to create a smooth and seamless process by which transfer students will be able to complete a Baccalaureate Degree at Robert Morris University. All policies and procedures of this agreement will be governed by the principles of current established agreements, (Illinois Articulations Initiative,) and benefit afforded transfer students as stated in the Robert Morris University *Undergraduate Catalog* unless there is a joint modification of these agreements. This articulation is intended to foster and promote continued communication between the two institutions in order to develop and perfect additional opportunities for articulated seamless transfer.

Students completing the AA degree program in Business Administration at Harper College and receiving their Associates in Arts degree are eligible to enroll in the Management Program at Robert Morris University at Junior level status to complete their Bachelor of Business Administration degree. Students will make a smooth transition with all credits from the Associates in Arts degree being accepted in their entirety.

Students are recommended to choose the following courses to meet requirements for the Associate degree at Harper College:

Students completing the Associates in Arts degree, including the recommended courses, can complete their Bachelor's degree at Robert Morris University in as little as 15 months.
